## 香港銀行學會的使命、目標和架構 Mission, Objectives and Structure of HKIB

#### 使命

香港銀行學會秉承精益求精的理念,因應內 地與香港瞬息萬變的銀行金融業發展,致力 為從業員提供優質專業培訓課程。

#### 目標

香港銀行學會成立的宗旨是:

- 積極開展學術研究和訊息交流,促進 香港銀行業的發展和創新,鞏固香港作 為國際金融中心的地位。
- 完善培訓課程,使銀行從業員通過進修,不斷提高服務水平,成為銀行界之優秀專業人士,並獲取認可的專業資格。
- 維護銀行界的利益。

#### 架構

香港銀行學會於 1963 年創立。在本地銀行和金融機構的大力支持下,學會於 1995 年正式發展成為獨立非牟利組織。學會的架構由議會及理事會組成,其成員為香港銀行及金融業的代表和領袖,理事會轄下另設有多個專責委員會。各專責委員會就發展方針及策略,提供方向及指引予秘書處,秘書處則負責執行日常會務。

#### 議会

議會負責制訂香港銀行學會的中期和長遠發 展路向,並就學會的事務向理事會提供意 見。

#### 理事會

理事會負責監管和統籌學會的日常運作,包括培訓、頒授資格,及與香港、中國內地和 海外組織聯繫等。

#### Mission

To continue to strive for excellence and to provide quality education for professional practice in response to the growing needs of the banking and financial industries in Hong Kong and the Mainland.

#### **Objectives**

The Institute is a professional organisation whose members represent a cross-section of the banking community. In very broad terms, the objectives of the Institute are as follows:

- To facilitate the consideration of matters of interest to bankers;
- To make available training opportunities for members to acquire knowledge in relation to the banking profession;
- To further the interests of banking.

#### **Structure**

Set up in 1963 and becoming an independent organisation in 1995 through the support of local banks and financial institutions, HKIB is a non-profit-making organisation made up of a Council and an Executive Committee, both represented by seasoned professionals and leaders of the banking and financial community in Hong Kong. Reporting to the Executive Committee is the Secretariat, which is responsible for the day-to-day operations of the Institute upon advice and guidance on development strategies and policy matters given by various subcommittees.

#### **The Council**

The role of the Council is to set the medium to long-term direction of the Institute and to advise the Executive Committee on the development of the Institute.

#### **The Executive Committee**

The Executive Committee is responsible for overseeing the management of the Institute, including provision of training, awarding of qualifications, and the collaborations of the Institute with organisations in Hong Kong, the Mainland and overseas.

### 主席獻辭 Chairman's Message

藉此機會,我謹代表香港銀行學會感謝各議會 銀行一直在財政上提供慷慨支持,令學會擁有 足夠資源不斷向前,繼續優化、擴展銀行人才 庫,以助業界持續發展。此外,理事會成員為 學會出謀畫策,提供多方面的協助,令學會繼 續成為行業認可的專業培訓及認證總匯。學會 的成功亦有賴廣大會員的支持,以及其行政團 隊的努力。於此,本人向他們致以衷心謝意。

在 2014 年,香港銀行學會邁進另半世紀的發展 道路,憑著堅穩的基礎,準備再創另一高峰。學 會專注於提供優質學習和認證機會,讓大中華區 的銀行從業員能獲得在新的專業能力框架下所 需的技能及知識,從而有更佳的事業發展。承接 與中國銀行業協會於 2009 年達成的資歷互認協 議,學會跟其簽訂新的補充協議,以深化彼此在 內地及香港的培訓和發展領域的合作,而此協議 正好配合香港特區政府於 2014 年 12 月與內地 商務部簽訂《內地與香港關於建立更緊密經貿關 係的安排》(CEPA) 框架下的新協議。

學會在中國銀行業協會的支持下成為在香港地區的《銀行業專業人員職業資格考試》(Qualification Certificate of Banking Professional, QCBP) 獨家考試合作機構。而 QCBP 證書已在去年獲內地人力資源及社會保障部認可。

香港銀行學會積極推動香港與內地同業的相互交流。繼 2011 年及 2013 年舉辦的「香港高級銀行家內地經濟金融研修班」取得高度成功後,學會與中國銀行業監督管理委員會(銀監會)黨校、中國銀行業協會合辦 2014 年「香港銀行家內地經濟金融研修班」,活動獲得內地經濟金融研修班」,活動獲得內地經營機構及業界的鼎力支持。銀監會主席尚福林先生、中國銀行業協會專職副會長楊再平先生及銀監會副主席郭利根先生以特別嘉賓的身家了出席研修班的活動。研修班有助香港銀行了解國策,以至內地的經濟及社會發展進程,同

As Chairman of the Executive Committee of The Hong Kong Institute of Bankers (HKIB), I am pleased to present this report highlighting the accomplishments and developments of HKIB in 2014.

First, on behalf of HKIB, I would like to thank our Council Banks for their generous financial support and valuable facilitation of HKIB's fruitful development. I also applaud the contributions of all Executive Committee Members who have devoted time and expertise to maintaining and enhancing the Institute's professionalism as an industry-recognised training and certifying hub. Moreover, I thank all our valued Members for their continued support, and the Secretariat for their hard work, commitment and efforts.

In 2014, HKIB proudly marched into its next 50 years of development. It has grown further and we have laid important foundations for future progresses. The Institute has stayed focused on equipping banking professionals in Greater China with the essential knowledge and skills they need to thrive on the new competency landscape by providing quality learning and certification opportunities. We reached a new supplementary agreement with the China Banking Association (CBA) to reinforce the commitment of the two organisations to deepen the collaboration in the area of training and development between the Mainland and Hong Kong. The agreement was made along with the signing of a new agreement between the Hong Kong SAR Government and the China Ministry of Commerce under the framework of Closer Economic Partnership Arrangement (CEPA) in December 2014. It was also signed under the existing mutual qualification recognition arrangement, which was set up in 2009.

With the support of the CBA, HKIB has become the only partnering Institute to hold Qualification Certificate of Banking Professional (QCBP) examinations in Hong Kong. QCBP is recognised by HKIB, the China Banking Regulatory Commission (CBRC) and the Ministry of Human Resources and Social Security in the Mainland.

HKIB's values of bridging Hong Kong and Mainland bankers, and fostering banking cooperation and knowledge exchanges between the two regions evidenced by the holding of the 2014 Mainland Economics and Finance Elite Seminar for Hong Kong Banking Executives with the collaboration of the China Banking Regulatory Commission (CBRC) Party School and the China Banking Institute (CBI). The seminar was a resounding success. The programme received full support from Mainland authorities. Mr. Shang Fulin, Chairman of the CBRC; Mr. Yang Zaiping, Executive Vice President of the CBA; and Mr. Guo Ligen, Vice Chairman of the CBRC were among the special guests. The programme facilitated Hong Kong bankers in expanding their China horizons and networks.

在香港金融管理局(金管局)的引領下,香港擁有完善的金融監管框架,繼續發揮作為國際金融中心的角色和作用。作為金管局的可靠夥伴,香港銀行學會透過提供相關的培訓課程和考試,配合並支持金管局的各項政策與措施,促進其於業內順利落實執行。學會在2014年再次推出認可註冊機構(Als)董事企業管治課程,以助提升香港銀行董事局的管治質素。

此外,學會應金管局及私人財富管理公會的要求,為私人財富管理從業員能力標準框架下的「私人財富管理專業認證 (CPWP) 單元二:道德與合規」設計課程,學會亦被委任為該管元的先導培訓和考試機構。同時,私人財富管理公會委任學會為 CPWP 單元一的豁免機制提供專業評估服務。這些培訓和考試,連同「與監管機構對話」活動,均旨在建立符合道德的合規文化,加強香港銀行業的競爭力。

學會對旗下課程和資格實施質素保證政策及程序,確保它們緊貼不斷變化的市場需求及新的專業基準。「專業財富管理師 (CFMP)」資格已進行全面的課程內容更新及優化,加強了其有關私人銀行業務的內容,以更有效培育相關的人才。新 CFMP 課程預計在 2015 年內推出。

學會一直支持行業標準的發展。學會獲香港特區政府委任為專業撰寫機構,負責撰寫零售,以及企業和商業銀行的《能力標準説明》,其於2010年及2013年分別推出。及後,學會再度受托於政府,開展制定私人銀行業務《能力標準説明》的任務。學會對於可以在資歷架構的發展中,扮演如此關鍵的角色,感到很榮幸。

回顧 2014 年,學會在澳門的發展取得長足的成績。我們與澳門金融學會簽署合作協議,將在澳門合辦推出「銀行業資歷認證 (ABP)」課程。至於 CFMP,累計約 15% 澳門銀行從業員曾報讀或報考,令人鼓舞。

2014 年標誌著學會更進一步,充份體現作為會員「教育、認証、增加訊息及聯繫」的平台。 我們會繼續努力,增強培訓和認證實力,為會員和銀行業創造更高的價值。

Hong Kong's continued success as an international financial centre is backed by the leadership of the Hong Kong Monetary Authority (HKMA) and its effective regulatory framework. A trusted partner of the HKMA, HKIB has been supporting the regulator's policy implementation by offering related training programmes and examinations. In 2014, we offered another Corporate Governance Programme for Directors of Authorised Institutions (Als) to help raise the standards of banking corporate governance in Hong Kong.

To support the implementation of the Enhanced Competency Framework (ECF) for private wealth management professionals in Hong Kong, HKIB, at the request of HKMA and Private Wealth Management Association (PWMA), developed the curriculum for the Certified Private Wealth Professional (CPWP) Module 2 Ethics and Compliance of the ECF. HKIB was also appointed as the initial training and examination provider of the Module. Concurrently, HKIB is commissioned by the PWMA to provide professional assessment services for the grandfathering scheme on CPWP Module 1's training and examinations. These and other well-received programmes such as Regulators Dialogue aimed to build a culture of ethics and compliance for the banking industry.

HKIB's ongoing quality assurance process ensures that our training programmes and qualifications stay in line with changing market demands and new competency requirements. A syllabus review was initiated for the Certified Financial Management Planner (CFMP) programme to articulate its private banking component and help develop the corresponding talent pool. The enhanced CFMP syllabus is expected to be introduced in 2015.

Separately, we were appointed by the Hong Kong SAR Government as the Professional Writer for the Specification of Competency Standards for Private Banking, following our successes in drafting the Competency Standards for Retail Banking as well as Corporate and Commercial Banking in 2010 and 2013 respectively. HKIB is honoured to have played such a key role in the development of the Oualifications Framework (OF).

2014 was an active year for our Macao development. The Institute entered into a cooperative agreement with the Macao Institute of Financial Services (IFS) to co-launch the Accredited Banking Practitioner (ABP) programme in Macao. As for our CFMP programme, I am excited to share that as of 2014, about 15% of Macao's banking professionals had pursued the CFMP qualification.

2014 has been another successful year for HKIB. The Institute is synonymous with a platform where bankers are "educated, qualified, informed and connected". HKIB will continue to advance on its wide and deep portfolio.

香港銀行學會致力拓展及提升大中華區銀行業的人才庫,而於個人的層面上,學會的培訓協助銀行專業人士進修新知識及技能,讓他們在提升專業能力的框架下,提高競爭力及享有更大的發展空間。2014年取得的成功,加上逾50年的穩固基礎,令學會擁有更雄厚的實力成為區內的培訓及認證總匯。

回顧 2014 年,學會舉辦了一系列成功的大型 行業活動。「2014 香港銀行家峰會」於 9 月 23 日假香港會議展覽中心舉行,吸引逾 720 位 來自 135 間銀行及金融機構的人員參與,當中 大部份為管理及行政人員。除此之外,不少內 地、澳門及海外機構均派員赴此為期一天的盛 會。峰會以「新時代·新思維」為題,旨在探 討銀行業應如何迎接未來機遇和挑戰,例如互 聯網金融及流動電話銀行服務的廣泛應用等。

學會於 2006 年創辦「香港銀行學會傑出財富管理師大獎」,活動至今已成為香港財富管理業界其中一個最具代表性的獎項。於 2014 年舉行的第八屆「香港銀行學會傑出財富管理師大獎」的參加人數較上一年有顯著增長,並新增設「最佳提名機構獎」。活動對財富管理的專業水平之提升和知識交流的貢獻均獲業界一致認可與重視。

學會堅守其作為會員「聯繫、教育、信息及認証」平台的宗旨。我們在 2014 年繼續提供多樣化、獲得業內正面評價的持續專業發展機會,包括「與監管機構對話(Regulators Dialogue)」、「傑出講者系列」、「午餐座談會系列」及免費講座。

It is my honour to serve as the CEO of The Hong Kong Institute of Bankers (HKIB) and report the highpoints of HKIB through 2014.

HKIB owes its continued success to the leadership of its Council and Executive Committee, the support of its Members and the banking industry, and the hard work and dedication of the Secretariat. On behalf of the Institute, I would like to extend my gratitude to all of them.

Expanding and enhancing the banking talent pool to sustain banking development in Greater China is a key driver for advancement at HKIB. Equally important is we help banking professionals develop knowledge and skills that will enhance their value to their organisations and will open new career doors for them on the new competency landscape. The accomplishments in 2014, together with the Institute's 50-year foundation of excellence, provided strong fundamentals for the Institute to become a regional training and certification hub.

Further, 2014 saw the continued successful holding of an array of substantial industry events. The 2014 HKIB Annual Banking Conference was held on 23 September at the Hong Kong Convention and Exhibition Centre. The whole-day conference attracted a full house of over 720 participants from 135 banks and financial institutions. In addition, banking professionals and delegates from Mainland China, Macao and overseas were invited to attend this influential event. The conference, themed "The Paradigm Shift", zoomed in on upcoming changes of the industry and discussed how the industry should react to emerging challenges and opportunities such as the use of digital and mobile technology.

The Institute's Outstanding Financial Management Planner Awards, launched in 2006, is one of the most representative events of the wealth management industry in Hong Kong. Its 8th edition achieved evident growth from the previous year and was enriched with a new Top Nomination Award. The contest's value in raising professionalism and providing a knowledge exchange platform is industry acknowledged.

HKIB stays true to its mission to "connect, educate, inform and qualify" banking professionals. In 2014, we continued to provide a diversity of well-received, highly rated continuous professional learning opportunities including Regulators Dialogue, Distinguished Speakers Series and Luncheon Series talks, and free seminars.

學會的培訓以高質素見稱,在業內有高度的認受性,不單符合行業能力以至學術水平的要求,更切合銀行業務的需要。我們貫徹執行嚴謹的課程質素保證和提升機制,為「專業財富管理師 (CFMP)」課程進行複審,更新及優化其內容。在 2015 至 2016 年,「香港銀行學會會士(AHKIB)」及「銀行業專業認證 (CP)」亦有計劃進行課程複審。

此外,學會遠赴孟買參加每兩年舉辦一次的「第十五屆亞太區銀行學會協會會議」。會上,學會與海外同業分享經驗,積極建立國際間的聯繫網絡,加強未來銀行人才發展跨地區合作的基礎。

學會在 2014 年期間還著手啟動多個優化項目,包括改進會員架構及對品牌重新定位的構思。會員架構的改進工作將於 2015 年開始,預計於 2016 年完成。相信提升後的會員架構將更能配合會員的需要,突顯他們的專業資格及地位。此外,學會的網站將進行全面升級,它將擁有更簡便的介面及更強的功能,並會提供更多實用資訊。

關於品牌的重新定位工作,學會將通過舉辦更 多樣化的培訓及相關活動,並邀請會員、行業 及社會各界的參與,以優化香港銀行學會品牌 的價值,令它享有更高的認受性,令會員受惠。

學會在 2014 年實現了長足的進步。我們將堅定不移地促進銀行業人才發展,並滿足會員專業發展的新需求。

HKIB's programmes offer high-quality learning experience and demonstrate compliance with industry competence and academic standards. Moreover, they meet banks' organisational requirements. This is the result of our effective quality assurance and improvement work. Besides the Certified Financial Management Planner (CFMP) programme, our Associateship Examination (AHKIB) and Certified Professional (CP) programmes will be reviewed starting in 2015.

On the international networking front, the Institute took part in the Asian-Pacific Association of Banking Institutes 15th Biennial Meeting in Mumbai. The meeting was highly valued that it allowed us to expand our network with comparable organisations in the region, strengthening the groundwork for cross-border cooperation in banking talent development.

### 助銀行家實現持續卓越的表現 Helping Banking Professionals Achieved Continued Excellence

區內及全球經濟環境正經歷急速變化,銀行經營環境遠較以往複雜,競爭更為加劇,出現了所謂「新常態」。銀行業如何把握在「新常態」下的全新機遇及如何重塑經營模式以保持增長及競爭力?香港銀行學會通過優質培訓,提升銀行從業員的專業知識及增強誠信服務能力,推動營運及管理模式創新,以配合「新常態」的發展,助業界在挑戰中計劃制勝策略。

#### 認可註冊機構董事企業管治課程

香港金融管理局(金管局)《監管政策手冊》 CG-1「本地註冊認可機構的企業管治」一章 要求認可註冊機構向董事提供持續企業管治培訓。學會應銀行的要求,為它們提供董事企業 管治課程,以配合金管局的相關要求與政策。 2014年,學會舉辦該課程的單元一及單元二, 主題分別是「認可註冊機構企業管治原則」」及 「認可註冊機構董事局監督之實踐」。學會 提供兩個相關持續發展課程,即「企業管治 提供兩個相關持續發展課程,即「企業管治 點:打擊洗錢」及「數碼化趨勢及網絡安全主 資訊科技與企業管治的關係」。學會將舉辦 多有關課程,以鞏固董事會的治理水平及素質。

#### 「與監管機構對話」系列

「與監管機構對話」系列自 2011 年推出以來深受業界歡迎,有效協助銀行在合規責任與卓越運營之間取得平衡,促進提升銀行治理。2014 年,學會舉辦了 4 次研討會,講解電子賬單及繳費服務平台 (EBPP) 及香港金融管理局(金管局) 保障金融消費者措施,共獲超過530 人出席。「與監管機構對話」系列是監管機構和業界之間有效的雙向溝通平台,其將繼續在實現監管政策的執行和遵守方面發揮明顯的作用。

### 「培訓」及「聯繫」平台

#### 傑出講者系列

學會定期邀請行內資深人士為「傑出講者系列」 活動擔任講者,就經濟和社會變化分享真知灼見,參加者亦可透過活動增強業內人脈資源, 有利於共同探討合作空間。2014年,學會舉辦 The banking landscape has become more complex and competitive amid fast and significant economic changes regionally and globally, and a "new normal" has emerged. How can banks capitalise on the new opportunities and how should they transform their business models to sustain growth and competitiveness in this "new normal"? HKIB enhances banker competency and integrity by providing quality training to help the industry foster innovations in operations and management to achieve sustained growth in the challenges of the "new normal".

#### **CDP programmes for Directors of local Als**

Module CG-1 of the HKMA Supervisory Policy Manual Corporate Governance of Authorised Institutions states that Als are required to provide orientation or induction courses and ongoing training to directors. HKIB has been engaged by banks as an external provider of such. In 2014, it offered two Core Modules - Corporate Governance for Als and Practical Aspects of Board Supervision for Als; and two continuing development programmes (CDP), namely, "Spotlight on Corporate Governance: Anti-Money Laundering" and "Digital Trends and Cyber Security: From IT to the Boardroom - Are you ready?". More related programmes will be organized in strengthening the quality of boardroom governance in the years ahead.

#### **Regulators Dialogue**

HKIB's Regulators Dialogue has been well-received by both the industry and regulators since its launch in 2011. It is known as an effective programme for banking practitioners to strike a balance between compliance obligations and performance excellence, as well as to enforce the monitoring in banks. In 2014, Regulators Dialogue events on decoding the Electronic Bill Presentment and Payment platform (EBPP) and the HKMA's approach to financial consumer protection were organised. Regulators Dialogue will continue to be successful in facilitating regulatory policy implementation and compliance. A total of 4 events were held in 2014 with a total attendance of over 530.

#### Seminars to "educate" and "connect"

#### **Distinguished Speakers Series**

The Distinguished Speakers Series aims to enhance bankers' understanding of the changing economic and social landscapes by engaging relevant prestigious speakers. It also offers a friendly networking opportunity to cultivate intra-industry cooperation. Two seminars under the series were held in 2014, respectively titled "The Global Financial Crisis: Lessons Learned, Regulatory Reforms and Way Forward" and "Explore the Features and Functions of Hong Kong Finance Functional Constituency".

了兩次「傑出講者系列」研討會,包括「全球 金融危機背景下的反思、監管改革的進程及未 來發展路向」及「香港管治的特色與金融界功 能發展的探討」。

「全球金融危機背景下的反思、監管改革的進程及未來發展路向」由學會和經綸國際經濟研究院合辦,逾200位銀行從業員參加,由美國聯儲局銀行及監管董事會代表 Sarkis D. Yoghourtdjian 先生主講。Yoghourtdjian 先生剖析全球金融危機的主因,以及在該經驗中的反思。問答環節由 Yoghourtdjian 先生和經綸國際經濟研究院主席沈聯濤先生一起主持,沈先生分享了他對監管機構監督和行業可持續發展的觀點。

至於「香港管治的特色與金融界功能發展的探討」,則由香港特別行政區第五屆立法會議員(金融界)吳亮星先生主講,他在講座上與會員及嘉賓探討香港成為國際金融中心的條件,及近年來有關金融業的議會工作。

#### 香港銀行學會午餐座談會系列

學會舉辦的午餐座談會深受銀行及金融界歡 迎,因其主題均為業界關注的事項,讓會員能 時刻緊貼業界的資訊脈搏。2014年4月,學會 舉辦題為「克服跨境打擊洗錢合規的挑戰」午 餐座談會,地點在香港銀行家會所,超過90名 來自 40 家銀行及金融機構人士踴躍赴會,當中 大部份均為法律及合規、打擊洗錢監控及營運 風險管理部門主管。本會有幸邀請到花旗銀行 亞太區打擊洗錢法規監管部高級副總裁羅一龍 先生; Mr. Vishwanathan Srinivasan, Regional Consultant, AML Compliance, LexisNexis Risk Solutions:滿地可銀行合規部主管區鍚邦先生: 渣打銀行集團金融罪案風險管理金融罪案情報 組方令立先生擔任座談會的嘉賓講者,他們各 自分享和討論在日益繁複的法規影響下銀行及 金融業所遇到的挑戰,尤其對跨國企業而言, 它們需要受多個司法區的管轄,更重要的是他 們應如何建立一個強大的監控系統以確保做到 百份百合法合規。

#### 免費講座

學會的免費講座是會員享有的眾多優惠之一。 講座的內容實務、理論兼備,主題廣泛且具啟 發性,深受業界支持。學會在 2014 年舉行了 共 6 次免費講座,其主題分別為:「了解新學 制一培育新一代」、「金融業的風險控管現況 "The Global Financial Crisis: Lessons Learned, Regulatory Reforms and Way Forward", jointly held by HKIB and the Fung Global Institute, and attended by over 200 banking practitioners of all levels, was delivered by Mr. Sarkis D. Yoghourtdjian, Assistant Director for Banking and Regulation of the Board of Governors of the Federal Reserve System in Washington D.C. Mr. Yoghourtdjian spoke on the primary underlying causes of the global financial crisis and what bank supervisors had learned from the adversity. He was joined by Mr. Andrew Sheng, President of Fung Global Institute, in the Q&A session. Mr. Sheng gave his views on regulator supervision and sustainable development of the industry.

The other seminar, "Explore the Features and Functions of Hong Kong Finance Functional Constituency", was delivered by Legislative Councilor Mr. Ng Leung Sing, who shared with attendees on the conditions for Hong Kong as an international financial center and the work of the Legislative Council in relation to the financial industry.

#### **Luncheon Series**

The topics of Luncheon Series are meticulously selected to help HKIB members keep abreast of the latest issues in the field. In April 2014, the Institute organised a luncheon talk titled "Overcoming Cross-Border AML Compliance Challenges" at the Hong Kong Bankers Club. The event attracted over 90 banking professionals from 40 financial institutions, most of whom were heads of legal and compliance, anti-money laundering and operational risk management. The highly eminent speakers included Mr. Haris Law, Senior Vice President, Asia Pacific Anti-Money Laundering ("AML") Compliance Department, Citibank (Hong Kong); Mr. Vishwanathan Srinivasan, Regional Consultant, AML Compliance, LexisNexis Risk Solutions; Mr. Daniel Au, Head of Compliance Department, Bank of Montreal; Mr. Steve Farrer, Senior Manager, Financial Crime Compliance – Intelligence, North East Asia, Standard Chartered Bank (Hong Kong). The speakers discussed challenges financial institutions faced from increasingly complex regulations, especially for multi-jurisdictional businesses, and how to implement a robust monitoring system to ensure full compliance.

#### **Free seminars**

Addressing topics of common interests, HKIB's free seminars are one of the many exclusive benefits enjoyed by our members. In 2014, the Institute offered 6 free seminars, respectively titled "Understand the New Academic Structure – Cultivate the New Generation", "Risk Scenario Assessment for Financial Industry", "Getting Connected in the Digital Era: Make Customer Interaction Easy", "Trusts – A Tool for Wealth Protection", "Managing Quality of Life in Stressful Working Environment" and "International Antimoney Laundering Regulations and Measures". The knowledge covered was readily applicable to real life.

講者全為相關主題的專家,擁有關於講座主題的第一手資料及親身經驗,以「金融業的風險控管現況評估」為例,該講座由學會和英國操作風險專業學會合辦,由該會副會長、國際知名的風險管理業專家 Mike Finlay 先生主講。此外,「與數碼世代接軌:銀行如何與客戶建立更緊密聯系」講座由學會、IBM 及香港中文大學聯合主辦,並在四季酒店舉行。

All the seminars were led by experts who had first-hand information and experience in the issues concerned. For example, the "Risk Scenario Assessment for Financial Industry" seminar was co-organised with the Institute of Operational Risk based in the U.K. and delivered by Mr. Mike Finlay, Vice President of the Institute of Operational Risk based in the U.K., a world-leading expert in operational risk management. The "Getting Connected in the Digital Era: Make Customer Interaction Easy" seminar was held at the Four Seasons Hotel. It was a co-hosted event between HKIB, IBM and The Chinese University of Hong Kong. The speakers were experts in their field from related departments of banks and the banking information technology sector.

### 促進大中華區銀行專業人才流動 Supporting Professional Mobility in Greater China

內地銀行業正積極拓展海外業務,其快速發展 為香港銀行及其從業員展示海量機遇。香港銀 行學會於 2005 年已成立北京代表處,為促進 兩地銀行業發展,提供跨境學習交流機會,助 業界把握當前的利好大勢。學會與澳門業界亦 建立密切夥伴關係,與當地業界共同成長。此 外,台灣業界視學會為中國銀行業知識的分享 平台,高度重視與學會的合作項目。

#### 成為內地外專局境外培訓合作機構

學會為內地業界提供培訓支援服務多年,去年 更榮幸地被國家外國專家局(外專局)列入境 外培訓合作機構及海外專家名單內,取得國家 認可資格,為內地銀行金融業人士提供境外培 訓,以配合內地對各行業實施的出國培訓計劃 要求。

獲國家外專局的認可突顯香港銀行學會作為專業金融培訓機構的地位,符合內地政府堅持培訓質量和效益的原則。學會的優勢還在於與業界有廣泛聯繫,除了銀行、金融機構,還有監管機構、香港及海外學術機構,故被認可為具可靠實力的行業性專業團體。

#### CFMP 認受伸延至國家層面

學會與中國銀行業協會早於 2009 年已簽署資格互認安排,確立「專業財富管理師(CFMP)」第一階段(內地版)與對方舉辦的「中國銀行業從業人員資格認證(Certification of China Banking Professional,CCBP)」《個人理財》證書為直接互認資格,而至於相關 CFMP 香港版的資格持有人,他們只需通過 CCBP「公共基礎」科考試,便可同樣取得 CCBP《個人理財》證書。

及後,CCBP 改組成為「銀行業專業人員職業 資格」(Qualification Certificate of Banking Professional,QCBP),而國家人力資源及社 會保障部(人保部)成為負責部門,中國銀行 業協會為執行單位。有見及此,學會與多個單 位探討,務求安排獲得延伸,結果在國務院港 Mainland banks are infused with vitality to extend their influence overseas. The fast advancement of the Mainland banking sector presents abundant opportunities for both banks and banking professionals in Hong Kong. HKIB hence established its Beijing representative office in 2005 to promote cross-boundary learning and networking opportunities. Concurrently, HKIB has achieved promising developments in Macao and its position being a crossover to China banking knowledge is highly valued by the Taiwanese banking sector.

#### **SAFEA** overseas training partner institution

HKIB is proud to become an overseas training partner institution and included in the list of overseas experts of State Administration of Foreign Experts Affairs (SAFEA), by which it is qualified to provide training to Mainland China's financial professionals at locations outside Mainland China in line with relevant overseas training requirements applicable to various industries.

Being SAFEA-recognised underscores HKIB's position as a highquality professional financial training provider with edges including a deep and wide industry network that encompasses banks and other financial institutions, regulators, as well as academic institutions in Hong Kong and other regions.

# Mutual recognition of CFMP and QCBP extended to national level

As early as in 2009, HKIB and the China Banking Association (CBA) entered into a mutual recognition agreement, by which CFMP Stage 1 (China Version) and the CBA's Certification of China Banking Professional (CCBP)—Personal Wealth Management Certificate were made direct mutually recognised qualifications; while CFMP Stage 1 (Hong Kong Version) holders were required only to pass only one CCBP subject, that is, "Banking Fundamentals" to obtain the same CBA certification.

CCBP has been transformed to Qualification Certificate of Banking Professional (QCBP) under the Ministry of Human Resources and Social Security of the People's Republic of China (MOHRSS), and the role of the CBA has changed to implementer. In view of such changes, HKIB worked with many relevant parties to have the original HKIB-CBA arrangement extended. HKIB successfully secured the support from the Hong Kong and Macao Affairs Office of the State Council to include the arrangement in the Mainland and Hong Kong Closer Economic Partnership Arrangement (CEPA) so that the original mutual recognition principle has remained in force and practitioners can continue to enjoy the related benefits.

澳事務辦公室的支持下,成功爭取將安排包括 於《內地與香港關於建立更緊密經貿關係的安 排》(CEPA)內,令原有的互認原則不受影響, 業界人士可繼續受惠。

總括而言,學會與中國銀行業協會之間就 CFMP的資格互認安排的原則與機制不變,唯 考試、科目等的名稱有所改動。原 CCBP 現稱 作 QCBP,並與 CFMP 第一階段(內地版)直 接互認,而相關 CFMP(香港版)證書持有人, 他們只需通過 QCBP《銀行業法律法規與綜合 能力》考試(原 CCBP「公共基礎」科),便 可獲得 QCBP《個人理財》證書,其包括《銀 行業法律法規與綜合能力》及《銀行業專業實 務》兩個科目。

香港銀行學會是中國銀行業協會在香港地區的獨家 QCBP 考試合作機構。QCBP 每年有近200 萬人應試,香港與國內所有城市同步進行考試。QCBP 獲人保部認可,屬全國級證書,因此 CFMP 在內地的認受性進一步加強,為CFMP持有人進入內地工作提供更優秀的條件。

#### 2014 年香港銀行家內地經濟金融 研修班

繼 2011 年及 2013 年舉辦的「香港銀行家內地經濟金融高級研修班」取得高度成功,學會與中國銀行業監督管理委員會(銀監會)黨校及中國銀行業協會合辦首屆「香港銀行家內地經濟金融研修班」。

研修班旨在讓參加者認識影響兩地金融業的內 地宏觀發展與政策,以啟迪他們的策略思維,

In sum, there are no changes to the principles and mechanism under the HKIB-CBA agreement; the amendments involve only some of the names used such as examination and subject names. At present, CCBP is called "QCBP", still mutually recognised directly with CFMP Stage 1 (China Version). As for CFMP Stage 1 (Hong Kong Version) holders, they only need to pass the QCBP "Banking Laws and Competence" (formerly CCBP "Banking Fundamentals" examination) to be awarded QCBP Personal Wealth Management Certificate, which comprises two subjects, "Banking Laws and Competence" and "Banking Professional Practice".

HKIB is the CBA's exclusively appointed QCBP examination administrator in Hong Kong. Nearly two million candidates in Mainland China sit for QCBP examinations each year. Examination centres in Hong Kong and Mainland China hold the examinations simultaneously. QCBP is a national-level, MOHRSS-recognised qualification, a status enjoyed also by CFMP holders. This CFMP-QCBP mutual recognition benefits the Mainland prospects of CFMP holders.

# Mainland Economics and Finance Elite Seminar for Hong Kong Banking Executives

Succeeding the extraordinary success of the 2011 and 2013 Mainland Economics and Finance Elite Seminar for Senior Hong Kong Banking Executives, HKIB rolled out the first Mainland Economics and Finance Elite Seminar for Hong Kong Banking Executives in collaboration with the China Banking Regulatory Commission (CBRC) Party School and the China Banking Institute of China Banking Association (CBA).

Held from 21 to 24 October 2014 at Langfang, a thriving city situated between Beijing and Tianjin and which is regarded by many as "China's Silicon Valley", the four-day seminar was attended by 68 banking heads and senior executives from 38 banks together with regulators. This 2014 version was tailored for department heads and senior executives with a focus on more practical topics. It was graced by the presence of Mr. Shang Fulin, Chairman of the CBRC; Mr. Yang Zaiping, Executive Vice President of the CBA; and Mr. Guo Ligen, Vice Chairman of the CBRC. The speakers were all prestigious figures, including Mr. Pan Guangwei, Director-General of the CBRC Party School; Prof Li Jianhua, Party School of the Central Committee of the CPC; Prof Xu Yan, National Defence University People's Liberation Army China; Dr. Xiang Dong, Director-General of Department II of General Affairs in Research Office of the State Council; Mr. Wang Xiaoyi, Deputy Administrator of the State Administration of Foreign Exchange; and Mr. Wang Zhaoxing, Vice Chairman of the CBRC.

The seminar majorly aimed at enlightening participants on national developments and policies that influence the Mainland-Hong Kong financial landscape. It comprised exchange sessions, group discussions, cultural activities and a visit to a relevant organisation. The participants took away with them first-hand high-level insights for more informed strategic and business development planning and initiatives. The topics covered "Interpretation of the Third Plenary Session of the 18th Communist Party of China (CPC) Central Committee", "Progress of Foreign

期望能將所學用於工作中,以促進香港銀行業的發展。討論主題及內容涵蓋「全面深化改革開放的號角—中共十八屆三中全會精神解讀」、「中國的利率與匯率改革進程」、「戰略思維與國家安全戰略」、「系統思維與創新能力」,以及「中國銀行業改革發展與外資銀行監管」等。

#### 澳門發展

學會作為擁有超過半個世紀人才發展經驗的行業組織,樂意為區內業界作出貢獻。學會與澳門金融學會在 2009 年攜手推出「專業財富管理師 (CFMP)」課程,課程在澳門的發展理想,2014年的統計數字如下:

- 385 位澳門從業員持有 CFMP 資格;
- 99 位從業員正通過公開課程及企業培訓接 受 CFMP 課程;及
- 澳門的報讀人次為 418。

此外,學會與澳門金融學會的合作關係進一步深化,兩個機構簽署了「銀行業資歷認證 (ABP)」合作備忘錄,在澳門合辦 ABP 課程,代表兩地業界在人才培訓合作上,以至學會在澳門的發展跨越另一里程碑。

學會於澳門舉辦多次為當地會員而設的持續進修課程,讓他們保持專業水平,其知識、眼界監管要求和市場變化同步。課程的主題涵蓋合規、最新投資產品及管理技能。2014年,學會在澳門推出了3個相關課程,主題分別是「投資工具及技術分析」、「巴塞爾Ⅲ實施情況介紹」和「職場技巧發揮及生活應用淺談:屋、樹、人分析學」。

#### 學會與台灣銀行業界分享交流經驗

學會自 2007 年已與台灣銀行業界維持緊密交流,每年應台灣信託業商業同業公會邀請,代為物色香港業界專家擔任其年度大型會議的主講嘉賓。2014 年度的年度會議假新北市政大公企中心舉行,題為「香港金融業辦理客戶投資國外及大陸地區業務概況説明」。是次講座由台灣銀行公會及台灣信託業商業同業公會合辦,逾 100 位業內人士參加。

#### **Macao development**

Equipped with over half a century's banking knowledge capital and resources for talent development, HKIB is pleased that it can assist Macao to develop its banking talent pool and competence. In 2009, the Macao Institute of Financial Services (IFS) and HKIB jointly launched CFMP in Macao. Since then, the programme has enjoyed growing success in Macao. A series of impressive figures in 2014 are testimony to this:

- there were 385 CFMP holders in Macao;
- 99 banking practitioners were taking public and corporate classes in Macao; and
- the number of enrolments in Macao was 418.

2014 marked a further milestone development in the ongoing MIFS-HKIB cooperation that the two organisations entered into an agreement to co-launch the Accredited Banking Practitioner programme (ABP) in Macao. The initiative is expected to take the Institute's development in Macao to new heights.

Further, HKIB organises continuous professional development (CPD) programmes regularly in Macao to support the related needs of our members in Macao. The topics cover compliance, the latest investment products and management skills. Three programmes were held in 2014, titled "Investment instruments and Technical Analysis for investment products", "Introduction of Implementation of Basel III" and "Workplace skills and their applications in daily life with House-Tree-Person Test (HTP)".

#### **Exchanges with Taiwan banking industry**

Since 2007 HKIB has been maintaining close exchanges with Taiwan's banking industry. Every year, the Institute helps the Trust Association of Taiwan to invite industry experts to be major speakers at its annual conference. The 2014 conference was held at the National Chengchi University Center for Public and Business Administration Education in New Taipei City, titled "An overview of how Hong Kong's financial industry does business in the Mainland and supports customers to invest abroad". The conference was co-organised by the Bankers Association of Taiwan and the Trust Association of Taiwan. It was well attended by over 100 industry professionals.



### 大型行業活動促進知識交流與業內緊密聯繫 Industry Events to Enlighten and Connect

#### 香港銀行家峰會

「2014年香港銀行家峰會」於9月23日假香港會議展覽中心舉行。峰會以「新時代‧新思維」為題,為期一天,吸引逾720位來自135間銀行和金融機構的行政人員參與,當中大部份為管理層及行政人員。除此之外,不少內地、澳門及海外機構均有派員出席此峰會。

峰會探討香港銀行業應如何迎接未來機遇和挑戰,例如互聯網金融及流動電話銀行服務的廣泛應用,以及來自非傳統金融機構的激烈競爭、 人才發展、人民幣國際化的進程加快、以至香港和內地經濟愈趨一體化等。

華僑永亨銀行主席暨香港銀行學會理事會主席 馮鈺斌博士為峰會致歡迎辭。學會很榮幸獲得 香港特區財政司司長曾俊華先生蒞臨並擔任峰 會主講嘉賓。此外,香港金融管理局副總裁暨 香港銀行學會理事會副主席阮國恒先生、中國 銀行業監督管理委員會前主席劉明康教授及華 僑銀行集團行政總裁錢乃驥先生等41位業界領 袖於會上從宏觀角度探討不同主題。

上午環節除包括專家演説外,還舉行了專題小組討論。大會為與會者安排交流午宴。午後,與會者按個人選擇,參與由專家主持的專題研討會,其主題涵蓋銀行業務(零售、商業和私人銀行):探索業務及操作新思維;以及合規、操作及風險管理。

In addition, recognising hard work, dedication and success, as well as sharing best practices through awards can inspire enhancement of professionalism in the industry.

#### **HKIB Annual Banking Conference**

The 2014 HKIB Annual Banking Conference, themed "The Paradigm Shift", was held on 23 September at the Hong Kong Convention and Exhibition Centre. The whole-day conference attracted a full house of over 720 participants from 135 banks and financial institutions, most of whom were managers and executives. In addition, practitioners and delegates from Mainland China, Macao and overseas were invited to attend this weighty event in banking and financial industry.

The conference focused on upcoming changes of the industry and discussed how the industry should react to emerging challenges and opportunities such as the use of digital and mobile technology. It also explored the issue of increasing competition from non-financial institutions, talent development, accelerated RMB internationalisation and the growing economic integration between Hong Kong and Mainland China.

The conference was opened by Dr. Patrick Fung, Chairman of OCBC Wing Hang Bank and Chairman of the HKIB Executive Committee. The speaker list included 41 banking leaders and relevant experts, with Mr. John Tsang, Financial Secretary of the Hong Kong SAR being the keynote speaker. Other featured speakers included Mr. Arthur Yuen, Deputy Chief Executive of the Hong Kong Monetary Authority and Deputy Chairman of the HKIB Executive Committee; Prof. Liu Mingkang, former Chairman of the China Banking Regulatory Commission; Mr. Samuel Tsien, Group Chief Executive Officer, OCBC Bank and others.

The morning session was marked by insightful speeches and a panel discussion on paradigm shift. After the networking luncheon, the participants attended one of three expert-hosted streams that respectively focused on retail, commercial and private banking; transformation of the banking industry and ways to adapt to the changes; along with compliance and risk management.

HKIB is grateful of the continued support of the industry for the conference. It has been an effective continuous professional

#### 8<sup>th</sup> HKIB Outstanding Financial Management Planner Awards

The Institute's Outstanding Financial Management Planner Awards, rolled out in 2006, has grown to become one of the most representative events of the wealth management industry in Hong Kong. Its continued success in raising professionalism and providing a knowledge exchange platform are acknowledged and valued.

The 8<sup>th</sup> HKIB Outstanding Financial Management Planner Awards was concluded after 3 rounds of assessments respectively, by which 10 entries from each group were selected to 2nd round assessment, and 3 entries from each group made it to the Final Round. Total number of entries was over 200, an evident growth from that of the previous year.

HKIB and co-organiser CTgoodjobs.hk were excited to add the new Top Nomination Award to this latest version of the event. The award praises the crucial role played by nominating institutions that they provide the essential support, training and backup that eventually lead to the candidates' success in the contest.

Carrying on the proven tradition of success, the 8<sup>th</sup> HKIB Awards included three contesting categories: Group A, for practitioners with up to three years of experience and serving general customers; Group B, for those with over three years of experience and serving general customers; and Group C, for those serving High Net Worth (HNW) customers. Its geographic coverage included Hong Kong and Macao.

The judges, who were heads of wealth management and private banking, highly praised that the participants showed an overall enhancement in professional commitment, technical competence, as well as interpersonal and communication skills, reflecting a sustained uplift of professional standards in the wealth management industry.

## 培育、拓展銀行業人才庫 Cultivating and Expanding Banking Talent

銀行業面對區域經濟一體化,加上更加嚴格的監管要求,其經營環境正急速變化。要滿足合規要求、提升技術、加強風險管理,以及實施更好的企業治理等挑戰,銀行需更新招聘策略,並要求人才需具備新的知識和技能。香港銀行學會透過不同的平台及安排,著力吸引新人入行,實現薪火相傳,助業界及香港持續保持競爭優勢。

#### 於大專院校舉行職業講座

到大學及高中舉辦職業講座是學會協助業界吸納新一代人才的重要活動之一。講座內容包括向學生提供職位選擇、銀行業前景和入職要求等實用資訊。學會更會邀請銀行家及業內領導出席分享他們的工作經驗及願景,讓學生獲得相關的第一手資料。2014年,學會於大學及高中共舉行了14場職業講座。

#### 發展學生會員

凡有興趣投身銀行業的年青人可加入成為香港 銀行學會學生會員。學生會員有機會以學生大 使、司儀或出席者的身份參加學會年會、「香 港銀行家峰會」和各類交流活動等,獲得銀行 業的第一手資訊,認識在職銀行家,增強人脈 資源,為入行預先建立個人優勢。他們亦可享 有折扣價格使用學會的服務,包括考試費減半 的折扣優惠。

#### 畢業生實習推薦計劃

學會的「畢業生實習推薦計劃」協助銀行吸引 具備大學學歷、符合入職資格的年輕人入行, 他們必須是學會的學生會員,正在修讀大學第 3或第2年,若已通過最少一個學會專業科目 的考試,更可獲優先考慮。實習生可為銀行帶 來活力及創意,而銀行亦可提升僱主形像。 The banking sector has been going through rapid changes amid deepening regional economic integration and heightened regulatory activity. Meeting compliance requirements, upgrading technologies, enhancing risk management and implementing better governance are some of the issues to address. This has prompted demands for new knowledge and skills, and adjustments of staffing strategy. HKIB has been helping banks build the right and continual talent pool through a diversity of platforms and arrangements to help the industry, as well as Hong Kong, sustain a competitive edge.

#### **Career talks**

HKIB visits universities as well as secondary schools across the city to hold career talks to help students understand the banking career first-hand. Besides providing practical information such as the available career options, prospects of the banking industry and entry requirements, banking professionals and leaders attend these talks to share their real-life experiences, which the students find highly inspiring. In 2014, the Institute conducted a total of 14 career talks at universities and schools.

#### **Student Membership development**

The HKIB Student Membership is open to all full-time students interested in a banking career. By becoming an HKIB Student Member, young people can gain early exposure to the field of banking. They can make industry contacts and meet potential future employers, as well as receive forefront industry information at HKIB's events and functions such as the Annual General Meeting, the Banking Conference and networking receptions, as student ambassadors, masters of ceremonies or audience. Further, Student Members can enjoy the services of HKIB at discounted rates, including 50% off examination fees.

#### **Graduate Referral and Internship Scheme**

The HKIB Graduate Referral and Internship Scheme aims at helping banks recruit qualified young student talent and building a pipeline of college-educated, qualified young professionals. To be eligible, a youngster must be an HKIB Student Member who is in their 3<sup>rd</sup> or 2<sup>nd</sup> year of university study and preferably has passed one HKIB professional subject. Interns can bring new perspectives to banks, beneficial to the innovation process; at the same time, banks can strengthen their employer brands.

### 香港銀行學會優質培訓打造專業才能新形勢 A New Competency Landscape through HKIB Quality Training

香港銀行學會從本地銀行業人才搖籃,逐步發展為跨地域的培訓中心,以至銀行專業能力標準的制定者。而在打造專業才能的新形勢下,學會業內人才發展方面的影響力愈見深化。學會成立至今已超過50年,見證全球經濟走向一體化,其間銀行經營環境的條件亦從穩定、可預測,轉變至瞬息萬變,愈見複雜。然而,學會一直保持領先優勢,竭智盡力服務銀行業界。

#### 私人財富管理專業資格課程

私人財富管理公會 (PWMA) 於 2014 年推出「私人財富管理優化專業能力架構(「ECF」)。該架構乃由香港金融管理局(金管局)主持的工作小組負責制定,旨在為私人財富管理業務提供從業員核心競爭力及工作能力的行業基準,以便其進行從業員能力考核及提升專業能力。

架構下的考試包括兩個單元:單元一針對專業技能、行業與產品知識;單元二涵蓋專業道德、合法合規及操守層面。從業員修畢兩個單元,並通過考試,可獲頒「註冊私人財富管理師」專業資格。香港銀行學會作為銀行業的培訓夥伴,很高興獲委任為首間負責提供單元二的培訓及考試的機構。

單元二的首輪培訓和考試於 2014 年開始,估計約 1,000 位從業員將於 2015 年完成培訓。學會亦獲私人財富管理公會 (PWMA) 委任為「註冊私人財富管理師 (CPWP) 資格」的豁免機制提供專業評估服務。學會將積極支持金管局發展優化專業能力架構,以不斷提高銀行從業員的能力水平。

The role and influence of HKIB in banking talent development has deepened from being a training hub for the local banking industry to a cross-border talent cradle and a developer of competency benchmarks towards a new competency landscape. For over 50 years, HKIB has been a reliable partner of the industry, witnessing the growth of globalisation where the business environment has changed from one with stability and predictability to one characterised by continual changes and growing complexities. Still, HKIB has always been at the leading edge to meet the needs of banking professionals through generations.

# **Certification training for private wealth management practitioners**

An Enhanced Competency Framework ("ECF") was developed by a task force chaired by the Hong Kong Monetary Authority (HKMA). The framework was launched in 2014 by the Private Wealth Management Association (PWMA). It aims to become a common benchmark for private wealth management (PWM) institutions in determining the core competence and in evaluating the actual competence of their relevant staff.

ECF for PWM consists of two modules – Module 1, on technical, industry and product knowledge; and Module 2, on ethics and compliance – training and examination of the two modules lead to the certification of "Certified Private Wealth Professional" (CPWP). HKIB was appointed as the initial training and examination provider for Module 2 of CPWP for PWM practitioners.

Enrolment for the first round of training and examinations for Module 2 started in 2014 and about 1,000 practitioners would complete the training in 2015. HKIB was also commissioned by the PWMA to provide professional assessment services for the grandfathering scheme on CPWP. HKIB will proactively support the continuous development of the ECF initiated by HKMA to enhance the competency level of banking professionals.



#### CFMP 課程複審

學會為應對財富管理業人員日增的需求,已就「專業財富管理師(CFMP)課程」的各單元進行修訂及增潤,以確保其內容與時並進。相關的工作已於2014年7至9月進行業界咨詢,學會綜合銀行相關業務之主管、導師及學者的意見後,為CFMP課程制訂全面且適切的內容,同時更新教學材料和考試題目。課程的主要修訂如下:

- a. 為緊貼市場需求及更有效地反映新修訂課程 的內容,單元5至7之名稱作出了修訂;
- b. 根據財務和財富管理的綱要,重新組合單元 課題;
- c. 增加課題,提供深入的財富管理知識;及
- d. 更新產品知識及投資策略以配合 2008 年金融危機後的環境。

#### 為香港資歷架構發展作出重大貢獻

香港資歷架構(QF)旨在為各界人士提供清晰的香港資歷架構內持續進修路線圖,促進他們取得有質素保證的專業資格。學會是銀行業「行業培訓諮詢委員會」(諮委會)的成員,諮委會是業內人士就資歷架構及行業的人力發展交換意見的平台。

早於 2007 年,學會已獲政府委任為銀行業《能力標準説明》專業撰寫人,負責制定零售銀行的《能力標準説明》,其已於 2010 年完成並推出。及後,學會再度獲政府委任撰寫企業商業銀行,以及私人銀行業務的《能力標準説明》,足見學會在業界的廣泛代表性和認受性。

#### **CFMP syllabus review**

To meet the growing needs of wealth management practitioners in the banking industry, the syllabuses of all CFMP modules have undergone a review to ensure that they are up-to-date. Between July and September 2014, this CFMP syllabus review exercise went through an industry consultation. After consolidating the views and suggestions from relevant business heads of banks, subject trainers and academic experts, a comprehensive syllabus was formulated, and study guides, teaching materials and examination questions were enhanced accordingly. The major changes to the syllabuses are as follows:

- a. changes to the names of Modules 5, 6 and 7 to better reflect market needs and business coverage;
- b. realignment of curriculum topics under the financial and wealth management framework;
- c. enhancement with additional topics to provide in-depth knowledge of wealth management; and
- d. updated product knowledge and investment planning strategy relevant to the post-2008 financial crisis era.

## **Contribution to Hong Kong Qualifications Framework development**

The Hong Kong Qualifications Framework (QF) aims to provide individuals with a clear roadmap for continuous learning to obtain quality-assured professional qualifications. HKIB has participated in the Banking Industry Training Advisory Committee (ITAC), a platform for stakeholders to exchange views regarding the development and implementation of the QF.

As early as in 2007, HKIB was appointed by the Government as the Professional Writer of the Specification of Competency Standards (SCSs) for retail banking, which was launched in 2010. HKIB has since then been re-appointed to develop the SCSs for Corporate and Commercial Banking as well as Private Banking, a testimony of its capacity as an authoritative professional body representing the industry.
