香港銀行學會的使命、目標和架構 Mission, Objectives and Structure of HKIB

使命

香港銀行學會秉承精益求精的理念,因應內地 與香港瞬息萬變的銀行金融業發展,致力為從 業員提供優質專業培訓課程。

目標

香港銀行學會成立的宗旨是:

- 積極開展學術研究和訊息交流,促進 香港銀行業的發展和創新,鞏固香港作 為國際金融中心的地位。
- 完善培訓課程,使銀行從業人員通過進修,不斷提高服務水平,成為銀行界之優秀專業人士,並獲得認可的專業資格。
- 維護銀行界的權益。

架構

香港銀行學會於 1963 年創立。在本地銀行和金融機構的大力支持下,學會於 1995 年正式發展成為獨立非牟利組織。學會的架構由議會及理事會組成,其成員為香港銀行及金融業的代表和領袖,理事會轄下另設有多個專責委員會。各專責委員會就發展方針及策略,提供方向及指引予秘書處,秘書處則負責執行日常會務。

議會

議會負責制訂香港銀行學會的中期和長遠發展路向,並就學會的事務向理事會提供意見。

理事會

理事會負責監管和統籌學會的日常運作,包括培訓、頒授資格,及與香港、中國內地和海外 組織聯繫等。

Mission

To continue to strive for excellence and to provide quality education for professional practice in response to the growing needs of the banking and financial industries in Hong Kong and the Mainland.

Objectives

The Institute is a professional organisation whose members represent a cross-section of the banking community. In very broad terms, the objectives of the Institutes are as follows:

- To facilitate the consideration of matters of interest to bankers;
- To make available training opportunities for members to acquire knowledge in relation to their banking professions;
- To further the interest of banking.

Structure

Set up in 1963 and becoming an independent organisation in 1995 through the support of local banks and financial institutions, HKIB is a non-profit-making organisation made up of a Council and an Executive Committee, both represented by seasoned professionals and leaders of the banking and financial community in Hong Kong. Reporting to the Executive Committee is the Secretariat, which is responsible for the day-to-day operations of the Institute upon advice and guidance on development strategies and policy matters given by various subcommittees.

The Council

The role of the Council is to set the medium to long-term direction of the Institute and to advise the Executive Committee on the development of the Institute.

The Executive Committee

The Executive Committee is responsible for overseeing the management of the Institute, including provision of training, awarding of qualifications, and the collaborations of the Institute with organisations in Hong Kong, the Mainland and overseas.

主席獻辭 Chairman's Message



作為香港銀行學會理事會主席,我很高興透過 這年報為大家概述學會於 2015 年實現的重點 進程。

首先,我謹代表學會感謝各議會銀行向學會提供的財政支持,給予學會必要的資源以實踐使命。此外,學會感謝各議會和理事會成員在百忙中抽空支持學會的工作,有賴他們的寶貴意見與協助,讓學會於銀行專業培訓及認證的地位進一步鞏固。

此外,學會向所有會員衷心致謝,他們的積極 參與是對我們的最大鼓舞。藉此機會,學會亦 向秘書處的付出表達感謝。

在 2015 年,學會在多方取得成就,而培訓方面的重點發展是我們於下半年推出「專業財富管理師 (CFMP™)」(修訂版)。在此之前,我們邀請到銀行業及學術界的專家,以及監管部門為課程進行全面的審評,經增潤後的培訓和考試內容更切合從業員的需求。我們很高興修訂後的課程得到業界的積極反饋與支持。與此同時,2015 年第四季啟動了對「香港銀行學會會士 (AHKIB)」核心階段一「銀行業資歷認證(ABP)」的教學大綱檢討,以保持其優越質素。

此外,學會成功將旗下專業資格和培訓課程推廣至更廣大的地區。我們與澳門金融學會合作將澳門版本的「銀行業資歷認證 (ABP)」引入澳門市場,亦與澳門管理專業協會共同在澳門開辦首個「香港銀行學會會士 (AHKIB)」課程。學會對澳門銀行業人才培養及建立人才庫方面的支持,正不斷強化。

學會一直與香港金管局保持密切合作,以支持 「優化專業能力架構 (ECF)」的引入。在香港 金融管理局 (金管局)的支持下,學會舉行「與 監管機構對話」研討會,為會員解構最新的監 管事宜。為持續提高各階層的銀行從業員的競 爭力,學會一如既往地支持金管局,協助其為 銀行董事制定述職和進修教育計劃,以提升銀 行業整體的企業管理水平。 As Chairman of the Executive Committee of The Hong Kong Institute of Bankers (HKIB), I am excited to present this report highlighting the achievements and developments of HKIB in 2015.

I would first like to thank our Council Banks for their generous financial support. Their facilitation in HKIB's development has been invaluable. Moreover, the Institute is indebted to the time and commitment of all Executive Committee Members, who have contributed to the Institute's expanding and advancing role as a professional training and certifying hub for banking.

The Institute also extends its deep thanks to it valued Members for their support and participation, and the Secretariat for their hard work.

HKIB had sustainable developments on various fronts in 2015. The focal point in respect of training was the launch of the new Certified Financial Management Planner (CFMP™) enhanced programme in the second half of the year. Earlier, the Institute had worked tirelessly with subject experts from the industry, and academic and regulatory sectors to review the training and examination materials of the CFMP programme to assure they meet the changing needs of banking practitioners. We are glad that the programme has received positive feedback and support from the industry. Furthermore, the Institute is reviewing the Accredited Banking Practitioner (ABP) programme, the core level of the AHKIB qualification. The syllabus review exercise for ABP started in the fourth quarter of 2015.

Also in 2015, the Institute successfully expanded HKIB qualifications and programmes to banking practitioners in a wider region. First, we successfully launched ABP with the Macau Institute of Financial Services (MIFS), which allows us to uplift our support of Macau's banking sector to attract and cultivate talent. In addition, joining forces with Macau Management Association (MMA), HKIB rolled out its first-ever Macau-focused AHKIB programme, whose modules are delivered in Macau.

In addition to those related to the Enhanced Competency Framework (ECF), we launched a number of initiatives to strengthen our support to the Hong Kong Monetary Authority (HKMA). With the staunch regulator's support, we continued to organize Regulators Dialogue seminars to update banking practitioners on the latest regulatory issues. As another ongoing effort to enhance the competence of banking practitioners of all levels, we supported the HKMA in the development of induction and continuing education programmes for bank directors to raise the overall corporate governance standards in banking.

學會繼續尋求與中國內地銀行業的專業資格認證機構合作,建立相互認可機制。在《內地與港澳關於建立更緊密經貿關係的安排 (CEPA)》框架內,學會與中國銀行業協會簽訂補充協議,進一步推進香港與內地之間的相互認可計劃,並促進香港與內地之間的人才流動。另外,學會增設「香港銀行家對內地銀行知識課程系列」,提供了解內地銀行最新發展動態的平台,以切合學員對相關知識的需求。

我們在 2015 年成立了會員架構指導委員會, 該委員會致力檢討現有的個人及企業會員架 構,在其帶領下,新會員架構預計在 2017 年 推出。

學會在 2015 年推出五年計劃 "Pro5",將於 2016 至 2020 期間落實。 "Pro5"針對人才能 力建設及提升專業水平,指引學會開啟下一個 十年的新篇章。

學會在穩固的根基上,將繼續為會員和銀行業提供優質的人才培訓平台。

HKIB continued to seek mutual recognition arrangements with professional banking qualification providers in Mainland China. Under the framework of CEPA (Mainland and Hong Kong Closer Economic Partnership Arrangement), the Institute signed a supplementary agreement with the China Banking Association (CBA). This furthers the mutual recognition programme between Hong Kong and the Mainland, and encourages the flow of talent between the two regions. Separately, our China Banking Knowledge for Hong Kong Bankers programme series provided a platform for our members to understand the latest development across the border.

我謹代表學會衷心感謝議會和理事會、秘書處、 廣大會員和支持我們工作的所有人士,有賴您 們的參與和鼓勵,學會得以不斷向前邁進。

學會在 2015 年舉辦了更多的培訓活動,當中不少是首度推出。我們不斷創新、提高培訓及服務質素。除了定期舉行的研討會、培訓和交流活動,我們推出嶄新的「與法定機構專員對話」系列講座,邀請官方或半官方的法定機構專員代表分享最新的社會議題。另一嶄新系列是「銀行業新動態一實務更新」,其旨在讓會員掌握業界最新的趨勢及發展。

HKIB and HKCS will hence jointly launch education programmes and examinations on fintech, along with related seminars and events.

HKIB continued to live up its role as a thought leader and industry benchmark setter through its long-standing flagship industry events, including Banking Conference 2015, 9th HKIB Outstanding Financial Management Planner Awards, 6th China Outstanding Financial Management Planner Awards and "New Trends of Wealth Management New Normal" of the Cross Strait Four Regions Wealth Management Summit 2015.

The Certified Banker qualification, benchmarked at Level 6 of the Qualifications Framework in Hong Kong (HKQF) which is equivalent to master's degree level, will be structured on the banking qualifications framework with elements of the Enhanced Competency Framework (ECF) incorporated at the advanced and professional diploma levels. As for the new membership structure, it will reflect a clearer distinction between qualification-focused and experience-based membership categories. It will also lend more importance to developing a pipeline of members and future talent for the industry.

HKIB is here to facilitate the professional growth of both its Members and the industry based on a solid foundation of over 50 years of banking talent development. With our commitment and competence, we offer professional banking training and qualifications to help banking practitioners and the industry prosper in today's changing environment.

更密切的業界聯盟[,]為會員創造更大價值 Stronger industry alliances to serve Members better

學會與世界各地著名相關機構建立了一個強大的戰略合作網絡,在合作協議下,學會和各將伴共享專業知識、行業竅門和業界聯繫等至共贏的局面。學會和銀行業並肩同行超越是不過世紀,全面掌握經濟及市場變化,亦洞悉與別方資源需求。在全球化下,夥伴網絡展期實現跨境培訓和人才流動,是可持續發展的關鍵所在。在2015年,學會顯著拓展多方的協議,藉此推動其邁向更高的成就。

2015年建立更緊密強大的合作關係

學會與行內相關機構及不同行業結成戰略合作 夥伴關係,相互合作、交流、互換專業知識與 資源。這些夥伴關係帶來協同效應,互惠互利。 學會在 2015 年與 8 間機構達成合作協議,共 同推動銀行業的發展。

香港電腦學會

學會與香港電腦學會簽訂諒解合作備忘錄,共 同探討香港銀行業和資訊科技界之間在專業培 訓與發展方面的合作機會。預期雙方將合作推 出金融技術培訓課程、考試、研討會及其他相 關活動。首屆「香港資訊及通訊科技獎:最佳 金融科技獎」是雙方的初次合作,活動由香港 銀行學會主辦,並由香港電腦學會以專家身份 提供專家意見及專業資訊。

半官方機構

學會的培訓以多元化及實用性而贏得業界的認同。學會與半官方機構合作舉辦「與法定機構專員對話」培訓系列。該系列的首個研討會與香港平等機會委員會(平機會)合辦,於2015年7月舉行,平機會委派代表跟與會者分享圍繞活動議題「公平對待客戶」的訊息和見解。2015年11月,學會邀請到香港廉政公署會港商業道德發展中心的代表環繞銀行業操守事題,就如何強化業界道德文化和相關法規,案例及操守管理的最佳實踐展開討論。

HKIB prides itself in being part of a strong strategic network of reputable partner organizations. The strategic alliances enable the sharing of knowledge and expertise, with each partner benefiting from the strengths of the other and gaining competitive advantage. Supporting and facilitating advancement of the banking industry side-by-side for over half a century, HKIB is able to make sense of economic and market changes, and it understands that dynamic partnerships are essential for its sustainable development and the continuous growth of its training and qualification portfolio as well as services for Members. In 2015, HKIB established more significant local and overseas partnerships, which empowers it to achieve further success.

Accelerated Partnership Development in 2015

One pillar holding up the success of HKIB is strategic partnerships with relevant institutions in banking and other industries. HKIB works closely with its partners to exchange expertise, competence and resources for the advancement of the banking industry; as a result, the partnerships lead to synergy and mutual benefits. The breadth and depth of the Institute's partnerships was extended in 2015 with the addition of eight renowned organizations joining HKIB to foster banking development.

Hong Kong Computer Society

HKIB entered into a memorandum of understanding (MoU) with the Hong Kong Computer Society (HKCS) to explore cooperation between the Hong Kong banking and information technology (IT) sectors in professional training and development. HKIB and HKCS are set to co-launch education programmes and examinations on financial technology, along with related seminars and events. The ongoing inaugural Best FinTech Award is the first collaboration, in which the HKCS provides valuable expert support to HKIB, the leading organizer of the this new award.

Quasi-Government Bodies

The Institute's training is well received for its diversity and relevancy. It is joining forces with quasi-government bodies to offer its Commissioners Dialogue series of training. For example, the series' inaugural session was held in July 2015 with representatives from the Equal Opportunities Commission (EOC) sharing information and insights of "Treat Customers Fairly". In November 2015, the Commissioners Dialogue event titled "Bank on Integrity" was jointly offered with the Hong Kong Business Ethics Development Centre of Independent Commission Against Corruption.

私人財富管理公會

學會與私人財富管理公會攜手推出「註冊私人 財富管理師」單元二:操守及合規課程和考試, 以香港的私人財富管理從業員為主要培訓對象。

佛羅里達國際銀行家協會

學會和美國佛羅里達國際銀行家協會 (Florida International Bankers Association (FIBA)) 簽署 諒解合作備忘錄,研究於 2016 年引入該會的 美國《外國賬戶税務合規法案》課程。FIBA 是首屈一指的合規和反洗錢培訓機構,其課程的內容覆蓋美國以至世界各地的法規及要求。

澳門管理學院

學會與澳門管理學院簽訂合作協議,為澳門銀行從業人員提供專業資格培訓,助他們加入銀行和金融業,或為晉升作好準備。首度合作將於2016年首季在澳門推出「香港銀行學會會士」課程。

傳播媒體

自 2015 年 一 月 開 始 , 學 會 與 《 南 華 早 報 Classified Post》聯合出版《Banking Today》。 此外 ,《指標》雜誌亦成為第九屆「香港銀行學 會傑出財富管理師大獎」的合作伙伴。

提升現有合作關係 中國銀行業協會

學會與中國銀行業協會的合作關係始於 2006 年,雙方的合作在多方面實現了卓越成效,包 括加強香港與內地的交流、建立資格互認機制, 促進跨境執業及合辦培訓和業界活動。

雙方的夥伴關係在 2015 年進一步加強。學會為香港唯一獲授權舉辦「銀行業專業人員職業資格」(Qualification Certification of BankingProfessional (QCBP) 考試之機構,並於 2015 年 5 月和 11 月在香港舉辦 QCBP「銀行業法律法規與綜合能力」考試。QCBP 專業資格取得學會、中國銀行業監督管理委員會及中國人力資源與社會保障部三方認可。

另外,在《內地與港澳關於建立更緊密經貿關係的安排》(Mainland and Hong Kong Closer Economic Partnership Arrangement (CEPA))的框架內,學會與中國銀行業協會簽訂了補充協議,將對 CFMP™ (內地版)的認受由廣東省伸展至全國。

Private Wealth Management Association

HKIB works with the Private Wealth Management Association (PWMA) to develop Module 2: Ethics and Compliance of the Certified Private Wealth Professional (CPWP) programme for private wealth management practitioners and the corresponding examination.

Florida International Bankers Association

A MoU was signed between HKIB and Florida International Bankers Association (FIBA) to bring training on the US Foreign Account Tax Compliance Act (FATCA) to banking professionals in Hong Kong. FIBA is one of the top providers of education and anti-money laundering (AML) training in regard to global and US AML compliance issues.

Macau Management Association

HKIB signed a MoU with the Macau Management Association (MMA) to co-launch AHKIB in Macau in 2016. This is the first cooperation between HKIB and the MMA, aiming to provide professional qualification training for banking practitioners in Macau. Through HKIB's training, they can acquire essential banking knowledge with which they can jumpstart or advance their banking and finance careers.

The Media

HKIB has teamed up with Classified Post of South China Morning Post to publish Banking Today since January 2015. Moreover, the BENCHMARK magazine has become a new co-organizer of the 9th HKIB Outstanding Financial Management Planner Awards.

Elevated Ongoing Alliances China Banking Association

The collaboration between HKIB and the China Banking Association (CBA) dates back to 2006. The alliance has been fruitful that the two institutions have accomplished extraordinary progresses together in respect of exchanges between Hong Kong and the Mainland, encompassing mutual recognition of qualifications, professional mobility, examination and training programme administration and industry event organization.

The cooperative ties were enhanced in 2015. As the only coorganizer of Qualification Certificate of Banking Professional (QCBP) Examination in Hong Kong, HKIB held the QCBP "Banking Laws and Regulations and Comprehensive Competence" examination in May and November 2015. QCBP is mutually recognized by HKIB, the China Banking Regulatory Commission (CBRC) and the Chinese Ministry of Human Resources and Social Security.

In addition, a new agreement was signed between HKIB and the CBA under the framework of the Mainland and Hong Kong Closer Economic Partnership Arrangement (CEPA). The agreement extends the recognition of CFMP $^{\text{TM}}$ from Guangdong Province to the whole nation.

參與海外行業活動

學會遠赴海外參加業界活動,以取得最前尖的銀行人才開發資訊,並建立聯繫基礎,以探討合作機會。在2015 年 4 月,學會出席在首爾舉行的21st World Conference of Banking Institutes。大會主題是「通過人才發展實現金融創新」,而學會於會上為與會者簡報「與監管機構加強合作:專業能力個案分享」。

Participation in Overseas Industry Events

The Institute heads overseas to take part in industry events to stay abreast of global developments in banking, in particular, banking talent development, as well as build friendships and explore opportunities of cooperation. In April 2015, HKIB attended the 21st World Conference of Banking Institutes in Seoul. The event was titled "Financial Innovation through Talent Development", and HKIB shared with the audience a presentation on "Enhancing Mutual Cooperation with Financial Authorities: Case Sharing on Professional Competence".



與時並進,緊貼行業需求

Evolving with time to meet the best of industry needs

學會致力提升培訓之內容,務求為會員提供最切合現今和未來市場所需的知識和技能。在2015年,學會推出「專業財富管理師(CFMP™)」(修訂版),同時將繼續支持香港金融管理局的政策落實與執行。學會推出更多「優化專業能力架構(ECF)」相關的課程予私人財富管理從業員。於2015年年初,學會亦成立會員架構指導委員會,專責會員架構更新事務,目標在2017年推出新的會員架構。

專業財富管理師 (CFMP™)(修訂版)

學會的課程均需定期通過嚴謹的質素保證檢討,以確保各課程的適切性,讓參與者及資格持有人時刻保持競爭優勢。經過詳盡、全面的研究及廣泛咨詢後,學會在 2015 年 5 月推出「專業財富管理師 (CFMP™)」(修訂版),應對來數變的銀行界財務規劃及財富管理業。課程的修訂包括課程名稱及內容更新,以更累點市場需求。學會根據財務和財富管理以與實驗,以配合單知識、新產品的發展及投資策略,以配合2008 年金融危機後的經濟環境。

學會以會員的利益為先,因而為受修訂影響的 CFMP™ 課程參加者提供過渡安排。對於正在 修讀 CFMP™ 課程的考生,若他們未能於 2015 年 7 月前完成全部舊版課程及考試,他們可以 重新修讀並考取未完成階段的科目,而已完成 階段中取得的成績亦維持有效。此外,證券及 期貨從業員資格考試卷一、七及八和保險中介 人資格的考試等執業資格的考試,依然享有科目豁免。

「註冊私人財富管理師」單元二: 操守及合規課程

學會於 2015 年推出「註冊私人財富管理師」單元二:操守及合規課程,主要對象為香港的私人財富管理從業員,以協助香港金融管理局(金管局)落實執行「優化專業能力架構(ECF)」。 ECF由金管局策劃,旨在提升私人財富管理業的相關專業能力,以及道德和合規水平。 Moving forward with time and committed to continuous self-enhancement, HKIB undertook the endeavour to revamp one of its flagship programmes, Certified Financial Management Planner (CFMP™), and the programme's enhanced syllabus was successfully launched in 2015. HKIB stays ahead of the changing world and workplace, equipping Members with present and future-fit knowledge and skills for career development. In addition, the Institute's support to the Hong Kong Monetary Authority (HKMA) has been extended with its offering of more programmes on Enhanced Competency Framework (ECF) for private wealth management (PWM) practitioners in Hong Kong. 2015 also had the establishment of a Membership Restructure Steering Committee, responsible for matters relating to the introduction of a new membership structure in 2017.

Enhanced Syllabus for CFMP™

As an ongoing quality assurance process, HKIB conducted a syllabus review for Certified Financial Management Planner (CFMPTM) to ensure that the syllabus is up-to-date and can meet the industry needs of facing the changes in financial planning and wealth management. The enhanced syllabus took effect in May 2015. The changes centre around module and subject names in an attempt to better reflect the subject matter enhancement for market needs and scope of business coverage; a realignment of topics under the framework of financial and wealth management; addition of new topics to provide in-depth knowledge on wealth management; and updates to product knowledge and investment planning strategy to cater to the post - 2008 financial crisis environment.

Members' benefits are the priority of HKIB, and therefore, the Institute introduced thoughtful transition arrangements for affected CFPM™ candidates in Hong Kong. For candidates who were unable to complete the previous CFMP™ syllabus by July 2015, they could take or retake all subjects in the uncompleted stage of the syllabus; on the other hand, assessment results of a completed stage were not affected and remain valid. Moreover, for subject exemptions with licensing examination results such as Securities and Futures Commission (SFC) Licensing Examination Papers 1, 7 and 8, and Insurance Intermediaries Qualifying Examination (IIQE), the exempted modules are still valid in the enhanced syllabus.

HKIB upgrades its training programmes and all other events and services in a continuous and timely manner to ensure their relevancy to changing needs of both Members and the industry. It is HKIB's mission to provide banking professionals with the skills and knowledge, and qualifications required to tap on opportunities in the more diverse and demanding banking landscape.

會員架構優化

學會在2015 年年初成立會員架構指導委員會。該會負責檢視現有的會員架構、定位,以及其與香港銀行學會專業稱銜的配合情況。在2016年,學會的工作將聚焦於會員發展及會員架構優化調整。經調整及優化後的會員架構將更更能類銀行從業員的專業地位,同時強化及新會員類別,而每個會員類別將根據會員類別,而每個會員類別將根據會時時段的需要,並更能反映銀行業的的一個人會對別,而每個會員類別將根據會與規行業階段的需要,並更能反映銀行業出,以會會的行業代表性將進一步增強,以鞏固作為區內銀行培訓和認證中心的地位。

Ethics and Compliance of CPWP Programme for Private Wealth Management Practitioners

HKIB is entrusted with facilitating the implementation of regulatory policies and expectations through providing related training to banking professionals. In 2015, the Instituted offered Module 2: Ethics and Compliance of the Certified Private Wealth Professional (CPWP) programme for private wealth management practitioners in Hong Kong to support the Hong Kong Monetary Authority (HKMA) in carrying out the Enhanced Competence Framework (ECF). Masterminded by the HKMA, the ECF aims at enhancing the technical and ethical standards of the private wealth management industry.

HKIB is the initial provider of the Module 2 training programme and examination in coordination with the Private Wealth Management Association (PWMA). In 2015, HKIB scheduled nine extra public classes in meeting the overwhelming response from the industry. In addition, the Institute may organize inhouse programmes to suit specific requests of banks and PWMA members.

HKIB Membership Restructuring

The Institute established a Membership Restructure Steering Committee in 2015. The committee is responsible for strategizing and overseeing matters relating to HKIB's membership restructuring endeavour. The new HKIB membership structure is expected to be unveiled in 2017. The Institute will be busy conducting reviews and discussions on the existing structure in 2016. The consensus is that each membership category under the new membership structure will be tailored to members' specific needs at each stage in their banking and financial career, and the new membership structure will welcome banking professionals from the wider banking and financial industry, as well as looking for banking industry updates or individuals affiliation with the Institute. The proposed changes include the introduction of new individual membership types to reflect the modernized professional banking pathway. The new HKIB membership is set to allow for wider representation and engagement of practitioners and banks, together with members of the community, sustaining HKIB's status as the peak representative body in banking talent development in Hong Kong.

學會的培訓活動在 2015 年實現理想的增長, 共提供超過 220 個培訓課程及活動。而與 2014 年相比,報讀人數上升了約 80%。學會對此非 常鼓舞,因為作為人才庫開發者,這表明更多 的會員從中受惠。此外,學會推出一系列全新 培訓課程,以應對不斷轉變的多元化市場需求。 通過學會的培訓,有意入行的人士或新入入長 過過學會掌握行業知識基礎,繼而一展所事 從業員可掌握行業知識基礎,繼而一展所等 而擁有銀行工作經驗的可藉此邁向更高的的; 電段;至於管理層成員,他們可將所獲得的知 識應用於推動公司業務。

2015 年香港銀行非執董高級研修班

香港金融管理局(金管局)及中國銀監會黨校於2015年10月15日及16日聯合舉辦「2015年香港銀行非執董高級研修班」。 並由中國銀行業協會東方銀行業高級管理人員研修院及香港銀行學會協辦。16位來自香港主要銀行的獨立非執行董事參加在北京舉行的高級研修班。

研修班獲中、港兩地監管機構鼎力支持。金管局總裁陳德霖先生及中國銀監會副主席曹宇博士 為研修班致辭,中國銀監會主席尚福林博士、中國銀監會主席助理楊家才先生,以及中國銀行業協會專職副會長楊再平先生等與與會者交流。

研修班探討國際上如何看「一帶一路」戰略,亦分析中國的外交策略、戰略思維,以至創新能力等宏觀課題,與會的獨立非執行董事均表示獲益良多。

學會積極舉辦類似跨境研修班及交流活動,旨在協助業界領導了解內地發展,讓香港銀行業制定配合香港背靠內地的優勢策略、方針和合作框架。過往的相關活動包括 2011 年、2013 年的「香港銀行家內地經濟金融高級研修班」,及 2014 年的「香港銀行家內地經濟金融研修班」等。 都能讓兩地金融人才更有效互相了解、溝通及交流從而加強推動中、港兩地銀行及金融業之合作共融。

香港公開課程

學會提供的公開課程旨在向參加者解讀最新的銀行業議題,滿足從業員的持續專業發展(CPD)需求,其主題按需而定,涵蓋銀行業知識和技能,新產品及服務資訊、合規要求,以及行業發展等,協助從業員走在行業的領先位置,擁有合時及合適條件,以把握最新的機遇。在2015年,這類培訓活動涉及約60個不同的主題。

2015 has been a particularly busy year in terms of training events delivered by HKIB, which totalled over 220. Further, compared with 2014, the enrolment increased about 80%. HKIB is excited to see the number surge as a talent developer because that shows more members have benefited from its quality training. It also rolled out an array of new programmes to meet the changing and diverse market needs. Through HKIB's training, those taken an interest in banking or newer practitioners can acquire banking essentials; the experienced can take their next career steps; senior management members can further their banks' progresses.

High Level Seminar for Independent Non-Executive Directors 2015

The High Level Seminar for Independent Non-Executive Directors 2015 was held on 15 and 16 October 2015. There were 16 Independent Non-Executive Directors from major banks in Hong Kong attended the event in Beijing. The event was jointly organized by the Hong Kong Monetary Authority (HKMA) and the China Banking Regulatory Commission (CBRC) Party School and supported by the China Bankers Institute and the Hong Kong Institute of Bankers.

The seminar received full support from regulators in the Mainland and Hong Kong. Mr. Norman Chan, Chief Executive of the HKMA, and Dr. Cao Yu, Vice Chairman of the CBRC delivered insightful speeches. Dr. Shang Fulin, Chairman of the CBRC; Mr. Yang Jiacai, Assistant Chairman of the CBRC; and Mr. Yang Zaiping, Executive Vice President of the CBA exchanged views with the participating independent non-executive directors.

It decoded the "One Belt, One Road" initiative from global perspectives. Other macro topics included the Mainland's foreign policy, strategic thinking and innovation capacity. The participants said they benefited substantially.

Such cross-boundary high-level learning and exchange events can help banking leaders gain a deeper understanding of Hong Kong's advantage being the gateway between the Mainland and the rest of the world so that they can formulate aligning business strategies. Moreover, enhanced interaction between bankers in the two regions favours Mainland–Hong Kong economic integration. The precedents included the Mainland Economics and Finance Elite Seminar for Senior Hong Kong Banking Executives, held in 2011 and 2013 respectively, as well as the Mainland Economics and Finance Elite Seminar for Hong Kong Banking Executives in 2014.

Public Programmes in Hong Kong

HKIB's public programmes are themed on the latest banking topics to suit the continuing professional development (CPD) needs of banking professionals. The programmes equip participants with the knowledge and skills to stay on top of new products and services, changes to rules and regulations, legal and compliance issues, and industry developments. In 2015, the programmes covered about 60 different topics.

Regulators Dialogue

To strengthen the communication between the Hong Kong Monetary Authority (HKMA) and authorized institutions (Als) in Hong Kong, HKIB has been designated by the HKMA as the organizer for the Regulators Dialogue series since 2011. The series aims to provide a platform for Als to interact directly with representatives from the HKMA on key compliance issues. In 2015, four of such events were organized, namely:

資歷及認證課程

學會提供的資歷及認證藍圖專為銀行從業員而設,讓他們有效率地提高正規的證書資歷,助他們發展個人事業。藍圖的優勢非常明顯,亮點包括前瞻性、高學習效益、多個入學點、可銜接學會及其他機構的課程,以及靈活的轉學與過渡安排。

學會一直與金管局密切合作,以支持「優化專業能力架構(ECF)」的引入。「優化專業能力架構一私人財富管理」由金管局推出,為私人財富管理從業員,訂立核心專業能力及持續專業發展的基準。學會與私人財富管理公會合作設計並完計,與一個人財富管理師」單元二:操守及課程的課程。學會作為「註冊私人財富管理師」單元二:操守及課程,以課程。學會作為「註冊私人財富管理師」以課程的對當行及私人財富管理公會的會員要求學會協辦內部培訓班,以配合個別培訓需要。單在 2015 年,學會的「註冊私人財富管理師」課程的報讀人數超過 1,600 人。

澳門培訓課程

The Institute specifically offered "Banking and Financial Knowledge for Information Technology Professional Luncheon Series: An Overview of Hong Kong Banking and Financial Services Sector for IT Professionals (Part I)" and "Banking and Financial Knowledge for IT Luncheon Series: An Overview of Hong Kong Banking and Financial Services Sector for IT Professionals (Part II)" to highlight the critical role financial technology plays in Professionals - banking today in addition to "E-Banking: Regulatory and Security Perspectives" and "Client Onboarding: the Fastest One Wins".

Directors Training

The HKIB Directors Training covers industry issues and regulatory updates relevant to the supervisory roles of directors in the banking industry. The training supports the HKMA initiative to strengthen the quality of boardroom governance in banks. The following Directors Training programmes were organized in 2015:

- 1. "Directors Training: Implementation of Basel III in Hong Kong with Regulatory Requirements"
- 2. "Directors Training: Mainland Banking Myths and Risks ~ What should you know as a bank director?"
- 3. "Directors Training: Solidification of Board Supervision on Risk Controls and Risk Culture for 'New Normal"
- 4. "Directors Training: Resolution Regime for Financial Institutions in Hong Kong"

Qualification and Certificate Programmes

HKIB runs a qualification and certification roadmap tailored for banking professionals to upgrade their formal training credentials as they advance their careers. The roadmap offers forefront and learner-friendly edges such as multiple entry points, articulation possibilities both inside and outside HKIB, and efficient transfer and transition arrangement.

In support of the implementation of the Enhanced Competence Framework (ECF), masterminded by the Hong Kong Monetary Authority to enhance the technical and ethical standards of the private wealth management industry, HKIB works with the Private Wealth Management Association to develop and provide the training of Module 2: Ethics and Compliance of the Certified Private Wealth Professional (CPWP) programme for private wealth management practitioners. Further, HKIB, as the initial provider of the programme's examination, introduced the corresponding grandfathering provisions in 2015. To meet market needs and the overwhelming response, HKIB schedules extra public classes from time to time, while offering the choice of in-house corporate-specific training for banks and and PWMA members. In 2015 alone, HKIB's CPWP programme recorded an enrolment of over 1,600.

Training Programmes in Macau

HKIB delivers CPD Public Programs in Macau for CFMP™ holders and banking professionals regularly in the city. Over 300 enrolments were received for 5 different programmes. The topics were "2015 Economic Forecast and Investment Analysis", "Anti-money Laundering and Counter Terrorism Financing Seminar", "Wealth Management Development and Opportunity in China Market", "From the prospective of banking supervision on Risk Management" and "The Relationship between Internet Finance and Big Data and the Impact on Banking Industry".

「2015 年度香港銀行家峰會」於 2015 年 9 月 25 日假香港會議展覽中心圓滿舉行。整天的峰會座無虛席,吸引了來自超過 150 間香港、內地、澳門、越南及其他海外銀行、金融和專業機構,超過 760 名代表出席。

「2015 年度香港銀行家峰會」以「新格局、新 常態」為主題,探討銀行業應如何自我裝備, 面對挑戰,並尋求創新方式在新監管環境及新 HKIB is where bankers get "informed, connected, educated and qualified". Every year, the Institute organizes a range of grand industry events bridging banking visionaries and forward-thinking dignitaries with banking professionals who keen to expand their networks, get inspired and take their careers and businesses to the next level. Through these large-scale events, the Institute facilitates bankers to be in the middle of the action.

The inaugural Best FinTech Award

The Institute has been appointed the leading organizer of the new Best FinTech Award under the Hong Kong ICT Awards. Launched in 2015, the event overlaps into 2016 and will have its awards presentation ceremony in April 2016. It covers three streams – Banking and Insurance, Capital Market and Emerging Solutions. The Hong Kong ICT Awards is steered by the Office of the Government Chief Information Officer, and organized by information and communications technology (ICT) industry associations and professional bodies in Hong Kong.

Banking and technology are inseparable today with the exponential use of computers and mobile devices. To grow sustainably, banks must out-think and out-do the existing with relevant ICT solutions that enhance the customer experience. HKIB hopes to facilitate the collaboration between the banking community and the fintech (financial technology) sector through organizing The Best FinTech Award. The event not only reinforces HKIB's unrivalled industry network and banking knowledge capital but also its brand as a progressive organization that evolves with time. Further information of the Best FinTech Award and the winner list will be published in HKIB Annual Report 2016.

HKIB Annual Banking Conference 2015

The HKIB Annual Banking Conference 2015 was successfully held on 25 September at the Hong Kong Convention and Exhibition Centre. The whole-day conference attracted a full house of over 760 participants from over 150 banks, financial services institutions and professional organizations in Hong Kong and other regions, including the Mainland, Macau and Vietnam.

The 2015 conference was given the themed "Reshaping Banking for the New Normal". It focused on how banks should prepare themselves for challenges and find new formulas to achieve sustainable growth under the new reality driven by emerging regulations and competitions. Other topics discussed included "One Belt One Road", Stock Connect programmes and Mainland-Hong Kong Mutual Recognition of Funds.

學會舉辦的「香港銀行學會傑出財富管理師大獎」旨在透過嘉許業界精英,以提高業界的專業水平。在 2015 年,學會與《指標》雜誌和《CTgoodjobs》攜手主辦這項盛事。2015 年的比賽加入全新的「最佳務實財富管理師論壇暨同業投票」評選,除了 12 位專業評判外,數百位同業同時投票評分,為參加者帶來更嚴謹的挑戰。

秉承過往成功的經驗,第九屆「香港銀行學會傑出財富管理師大獎」的比賽共分為3個組別,分別是:A組一參加者擁有3年或以下經驗、向一般客戶提供服務:B組一擁有3年以上經驗、向一般客戶提供服務:以及C組一服務高端客戶之從業員。參加者包括來自香港及澳門地區的財富管理精英。

Prof. K. C. Chan, Secretary for Financial Services and the Treasury of the Government of the HKSAR, was the opening keynote speaker. HKIB was also honoured to have 48 chief industry leaders and influencers to be the events' featured speakers and panelists. Dr. Patrick Fung, Chairman of OCBC Wing Hang Bank and Chairman of the HKIB Executive Committee gave his warm welcome to all the guests and participants.

The morning session was marked by insightful speeches and a CEO panel discussion on the new normal of the banking industry. After the networking lunch buffet, the participants attended one of three expert-hosted streams on Banking Business, FinTech Innovation and Compliance and Risk Management respectively.

The conference was well received with 97% of attendees rating it as "excellent" or "good". The HKIB Annual Banking Conference has been an effective platform for exchanging constructive ideas with abundant opportunities for business and career networking.

9th HKIB Outstanding Financial Management Planner Awards

The HKIB Outstanding Financial Management Planner (OFMP) Awards aims at providing a high standard platform to the industry practitioners. In 2015, HKIB jointly organized the 9th HKIB OFMP Awards with the BENCHMARK magazine and recruitment portal CTgoodjobs.hk. The 2015 contest included the additional assessment of Peer Voting – Best Practice Wealth Advisory Forum, in which non-participating wealth management and banking professionals cast their votes to select the winners alongside the decisions of 12 judges, presenting a rigorous challenge to the entrants

Extending previous accomplishments, the 9th HKIB OFMP Awards was open to wealth management professionals in Hong Kong and Macau, and comprised three contesting categories: Group A, for practitioners with up to three years of experience and serving general wealth management customers; Group B, for those with over three years of experience and serving general wealth management customers; and Group C, for those serving High Net Worth (HNW) customers.

The event has promoted prefessionalism in the wealth management industry. The Awards Presentation Gala Dinner was held in January 2016, attended by top bankers, financial professionals and regulators in Hong Kong and Macau.

6th China Outstanding Financial Management Planner Awards

Since 2007, the Institute has organized the China Outstanding Financial Management Planner Awards with the China Banking Association (CBA) and Financial News. Every year, HKIB convenes a judging panel of representative figures from regulators, banks and financial institution and the academic community in the Mainland and Hong Kong, giving the event recognition and authority. The event has grown to become a premium brand in the Mainland, with cumulative total number of entries exceeding 3,000 as at the end of 2015.

The Cross Strait Four Regions Wealth Management Summit 2015 was followed by The 6th China Outstanding Financial Management Planner Awards prize presentation and the kick-off ceremony of its 7th version. The award categories are divided according to the skill set and experience of practitioners: less than 2 years of experience; 2 or over 2 years of experience; and new to the 2011 contest, those serving high net worth customers.

Through acknowledging the abilities of talented wealth management practitioners and promoting best practices that stress the application of professional ethics, the China Outstanding Financial Management Planner Awards has been able to uplift industry standards and raising public awareness of the significance of financial planning.

Cross Strait Four Regions Wealth Management Summit 2015

To build an exchange platform between the banking and financial services industries in Hong Kong, the Mainland China, Macau and Taiwan to facilitate the development of wealth management market in the cross-strait four regions, the China Banking Association (CBA), HKIB and Financial Times jointly organized the Cross Strait Four Regions Wealth Management Summit.

Titled "New Trends of Wealth Management New Normal", Cross Strait Four Regions Wealth Management Summit 2015 was attended by over 150 industry practitioners. The guest speaker list was composed of the top management from banks and financial institutions, as well as regulatory bodies, who included Mr. Liao Min, Director-General, Shanghai Authority of China Banking Regulatory Commission (CBRC); Mr. Huang Wenge, Assistant Director, Banking Innovation Supervision Department, CBRC; Mr. Zhu Xiaohuang, Chairman of the Board of Supervisors, CITIC Group Corporation; Mr. Han Song, General Manager, Asset Management, Industrial and Commercial Bank of China Limited; Mr. Xie Wei, General Manager, Asset Management, Shanghai Pudong Development Bank; Ms. Carmen Chu, Executive Director (Banking Conduct), Hong Kong Monetary Authority; Mr. Wu Honglin, Chief Executive, Giant International Assurance; and Dr. Chan Sau San, Benjamin, Member of Executive Board, Macau Institute of Financial Services. In the afternoon, two roundtable forums were organised with the themes "The New Normal of Wealth Management" and "New Opportunities in Private Banking" respectively.

2015 滬港金融專業大學本科生交流 及考察計劃

2015年6月,香港銀行學會獲香港特區政府財經事務及庫務局邀請,為來自9間本地大學並將會參加該局舉辦「2015滬港金融專業大學本科生交流及考察計劃」的27位大學生提供「香港及內地銀行體制和服務」培訓課程。該計劃是得到財經事務及庫務局在上海市金融服務辦公室支持下,根據《關於加強滬港金融合作的備忘錄》而推出。

就業講座:加入銀行專業

學會積極到各大學舉辦就業講座和參加職業論壇,以吸引更多年青人入行,為銀行業注入新力軍。就業講座由資深銀行家主講,並配合簡報和答問環節,向學生講解銀行工作的多樣性、求賢若渴的部門、從業員的前途、應屆畢業生的機遇,成為銀行家所需的資格和個人條件等。在2015年,學會共舉行22次「加入銀行專業」就業講座,出席的學生總人數逾450人,足跡遍及8間院校,包括香港大學、香港中文大學、香港理工大學、香港城市大學、香港付工大學、香港理工大學、香港城市大學、香港付工大學、香港專業教育學院(黃克競及沙田)及聯合國際學院。

HKIB is well informed of the talent needs and expectations of the industry with regard to human resources, and thus it is knowledgeable about the skill competence and professional qualification for different banking roles, present and future. The Institute works closely with the academic sector to introduce career opportunities in banking to young jobseekers, building a qualified youth pipeline to help banks fulfil their strategic initiatives and support them to pursue market opportunities timely. HKIB strives to ensure the next generation of bankers is in place, armed with the right skills and qualifications, and ready to be on board.

2015 Cross-border Study Tour for Post-secondary Financial Talents

In June 2015, HKIB was invited by the Financial Services and the Treasury Bureau (FSTB) HKSAR to deliver a training programme on "Banking System and Services in Hong Kong and Mainland China" to 27 undergraduate students from 9 local universities who participated in the Exchange Programme of "2015 Cross-border Study Tour for Post-secondary Financial Talents". The Exchange Programme was introduced by the FSTB with the support from the Shanghai Municipal Government Financial Services Office under the Memorandum of Understanding Concerning Advancing Hong Kong-Shanghai Financial Co-operation.

Career Talks for Students

HKIB demonstrates its commitment to the future of banking through delivering career talks and participating at career forum for students at different universities. The talks, comprising presentations by experienced banking professionals and a question-and-answer session, address the diversity of a career in banking, banking areas with high demand for young talent and promising prospects, the career paths for fresh graduates, and the required credentials and attributes to become a banker. In 2015, the Institute held a total of 22 career talks titled "Banking as a Profession" for over 450 students at 8 colleges and universities, namely, The University of Hong Kong, The Chinese University of Hong Kong, The Hong Kong Polytechnic University, City University of Hong Kong, Hong Kong Shue Yan University, The Hong Kong Institute of Vocational Education (IVE) (Haking Wong and Sha Tin) and United International College (UIC).


