# Enhanced Competency Framework (ECF) on *Cybersecurity (Core Level)*Training and Examination Schedule – 2021

## **Important Notes:**

- 1. HKIB is appointed as the Professional Qualifications Assessment Agency effective from 1 August 2020.
- Learners who pass the examination under Assessment Agencies of Professional Qualifications with relevant work experience will be eligible to pursue a QF-recognised Professional Qualifications (i.e. ACsP) instead of a QF-recognised Certificate (i.e. Advanced Certificate for Enhanced Competency Framework on Cybersecurity).
- 3. Learners who have attended the same training earlier are welcome to attempt the examinations in the below intakes.
