

## Enhanced Competency Framework (ECF) on Credit Risk Management (Core & Professional Level) Training and Examination Schedule – 2021

### Important Notes:

1. HKIB is appointed as the Professional Qualifications Assessment Agency effective from 1 August 2020.
2. Learners who pass the examination under Assessment Agencies of Professional Qualifications with relevant work experience will be eligible to pursue the **QF-recognised Professional Qualifications** (i.e. ACRP/CCRP(CL)/CCRP(CPM)) instead of a QF-recognised Certificate (i.e. Professional Certificate for Enhanced Competency Framework on Credit Risk Management/Postgraduate Certificate in Credit Portfolio Management/Commercial Lending for Enhanced Competency Framework on Credit Risk Management).
3. Learners who have attended the same training earlier are welcome to attempt the examinations in the below intakes.
