Important Notes:

- HKIB is appointed as the Professional Qualifications Assessment Agency effective from 1 August 2020.
- Learners who pass the examination under Assessment Agencies of Professional Qualifications, with relevant work experience will be eligible to pursue a QF-recognised Professional Qualifications (i.e. CB) instead of a QF-recognised Diploma (i.e. Postgraduate Diploma in Credit Management/Treasury Management/Operations Management for Certified Banker).
- Learners who have attended the same training earlier are welcome to attempt the examinations in the below intakes. .
