1. It is compulsory for an individual to acquire a professional membership with HKIB for CPFInT(A) / CPFInT(M) / CPFInT(S-AIBD) / CPFInT(S-DLT) / (CPFInT(S-OBAPI) / (CPFInT(S-RT) certification. Holders have to maintain HKIB professional membership status and fulfil annual CPD requirements for their annual renewal.
2. It is for aged 60 or above.
3. On top of the re-registration fee for default member, certification renewal fee is also applied.
4. HKIB student members can enjoy 25% off training fee discount and 50% off examination fee discount respectively. However, those student members will no longer be eligible for The Pilot Scheme on Training Subsidy for Fintech Practitioners offered by the Government of HKSAR in the future.
