3	Delivery Mode	LIVE is delivered by Professor appointed by HKUST in face-to-face mode. VAT is delivered using Video-Assisted Training with pre-recorded videos and facilitation support of designated teaching assistant. Computer-based Exam is an on-site examination with the learner required to bring their own laptop (with camera and microphone function) to complete the examination via an online "QuestionMark" exam platform. The latest version of Google Chrome and/or Microsoft Edge needs to be installed.
4	Late Application	A late entry fee of HK\$200 will apply for late training and examination enrolment respectively.
5	Training Material	The training material (i.e. Study Guide) will be provided. In addition, learners have to purchase reference book(s) on their own as a part of the essential readings (if any). For details, please refer to the essential reading list in the Programme Handbook under each module.
6	Fee Discount	HKIB student members can enjoy 25% off training fee discount and 50% off examination fee discount respectively.
