

## Enhanced Competency Framework (ECF) on Fintech (Professional Level) Training and Examination Schedule

Learners who pass the examination under Assessment Agencies of Professional Qualifications with relevant work experience will be eligible to pursue the QF-recognised Professional Qualifications (i.e. CPFInT(M)<sup>1</sup>, CPFInT(S-AIBD)<sup>2</sup>, CPFInT(S-DLT)<sup>3</sup>, CPFInT(S-OBAP)<sup>4</sup>, CPFInT(S-RT)<sup>5</sup>).

4	<b>Late Application</b>	A late entry fee of HK\$200 will apply for late training and examination enrolment respectively.
5	<b>Training Material</b>	The training material (i.e. Study Guide) will be provided. In addition, learners have to purchase reference book(s) on their own as a part of the essential readings (if any).
