1. How can I complete the programme(s)* # and be eligible for applying the Pilot GSF Capacity Building Support Scheme (the Scheme)?

***Certificate of Achievement for Core Level Module 1 – 4 under ECF-GSF and Certificate of Achievement for Professional Level Module 5 – 10 under ECF-GSF**

- You are required to complete the module training (face-to-face/virtual) with an attendance of **70% or above** and pass a multiple-choice in-class assessment with a score of **70% or above** in order to be granted with the Certificate of Achievement of the relevant module, and to apply for the Pilot GSF Capacity Building Support Scheme.
- The multiple-choice in-class assessment is a **web-based assessment** which contains **10** multiple-choice questions. Each question carries equal mark.
- You will have **20 minutes** to take the in-class assessment.
- Your enrolment date of the programme must also be on or after the effective date of the eligible programme under the Scheme.

#Certificate of Completion for Core Level Module 1 – 4 under ECF-GSF and Certificate of Completion for Professional Level Module 5 – 10 under ECF-GSF

- You are required to pass a multiple-choice assessment with a score of **70% or above** in order to be granted with the Certificate of Completion of the relevant module, and to apply for the Pilot GSF Capacity Building Support Scheme.
- The multiple-choice assessment is a **paper-based assessment**. Each question carries equal mark.

5. How can I acquire confirmation from the HKIB on the successful “training exemption”?

You will be required to self-declare on completion of relevant in-house training programme(s) organised by an Authorized Institution with substantially overlapping syllabus coverage with respective module(s).

Before you are being awarded with the Certificate of Achievement for Core Level Module 1 – 4 or Certificate of Achievement for Professional Level Module 5 – 10; as a confirmation from the HKIB on the successful “training exemption”, you may also be required to provide supporting documents including but not limited to syllabus mapping summary, training course syllabus, etc. to the HKIB.

6. Do I need to apply for the subsidy by myself or The HKIB will represent me to apply it automatically when I have enrolled the programme?

You are required to apply for the subsidy on your own via The Scheme. You are also recommended to read the eligibility requirements for details beforehand. For details, please refer to <https://www.greentalent.org.hk/>

7. Is there any deadline for applying the Scheme after the completion of programme(s)?

You are required to submit the completed application form together with the required supporting documents via the website of The Scheme within 3 months from the date of completion of the programme. Late applications will not be processed.

8. If I lost my certificate and documentary proof, is there any charge to obtain a replacement of proof?
