7	Bridging Programme Entry Requirements	The programme is open to HKIB members and non-members. Applicants must hold one of the following qualifications: - Certified Anti-Money Laundering Specialist (CAMS) certification awarded by the Association of Certified Anti-Money Laundering Specialists; or - International Diploma in AML awarded by the International Compliance Association (ICA).
