6	Bridging Programme Entry Requirements	Chinese practitioners who have obtained a pass in Shenzhen-Hongkong-Macau Fintech Professional Programme (SHMFTPP) Level 1.
7	Remote Exam Mode	Candidates MUST attend the compulsory session named as " Rehearsal Practice Examination " to be held by HKIB about one week approximately before attending the formal "Remote Examination". A two device-approach will be adopted for both "Rehearsal Practice Examination" and "Remote Examination", for the purpose of real-time virtual invigilation and monitoring use. To ensure smooth examination operations, candidates are required to station at their own workplaces and prepare own computer, either desktop or laptop, along with a mobile phone which can be able to connect 'Zoom' application during both sessions.
